NOTICE ON THE HOLDING OF ORAL HEARINGS ON THE INQUIRY INTO THE REVIEW OF OWNERSHIP & CONTROL OF BROADCASTING SERVICES & EXISTING COMMERCIAL SOUND BROADCASTING LICENCES

The Independent Communications Authority of South Africa ("the Authority") published a Discussion Paper on the inquiry into the Review of Ownership & Control of Broadcasting Services & Existing Commercial Sound Broadcasting Licences, on 7 September 2002. The Discussion Paper was published in accordance with section 28 of the Independent Broadcasting Authority Act, 1993, as amended. The purpose of the Discussion Paper is to generate comment from all stakeholders on issues surrounding the review of ownership and control rules as set out in sections (48), 49 and 50 of the IBA Act; and the commercial sound broadcasting sector, particularly, Greenfields licences. The Discussion paper will also investigate the feasibility of issuing commercial sound broadcasting licences in secondary towns.

The Authority is going to hold oral hearings from 10 February to 18 February 2003 in Sandton.
