7.1 General

Access to information of private body

- Request for Access of Information to a record as contemplated in section 53(1) of the
 Act must substantially correspond with Form C of the Regulations as published in the
 Government Gazette, attached. Request to be addressed to Information's Officer
 stated in section A of this document
- The requester must identify the right that is sought to be exercised or to be protected and provide explanation of why the record is being requested.
- Request on behalf of a 3rd party by a requester, must provide proof of capacity in which request is made.

- 5.2 The request fee payable by a requester, other than a personal requester, referred to in section 54(1) of the Act is as published in the Government Gazette no. 23119, dated 15 February 2002.
- 5.3 The access fees payable by a requester referred to in section 54(7), unless exempted under section 54(8), of the Act is as published in the Government Gazette no. 23119, dated 15 February 2002.
