NOTICE 484 OF 2003**DEPARTMENT OF JUSTICE AND CONSTITUTIONAL DEVELOPMENT****PUBLICATION OF EXPLANATORY SUMMARY OF THE COMPULSORY HIV TESTING OF ALLEGED SEXUAL OFFENDERS BILL, 2003**

The Minister for Justice and Constitutional Development intends introducing the Compulsory HIV Testing of Alleged Sexual Offenders Bill, 2003 in the National Assembly shortly. The explanatory summary of the Bill is hereby published in accordance with Rule 241(c) of the Rules of the National Assembly.

The Bill makes provision for a speedy procedure by which a victim of an alleged sexual offence may apply for the compulsory HIV testing of the alleged offender; and for the disclosure of the test results to the victim and the alleged offender; and to provide for incidental matters.
