LICENSE FEES PAYABLE BY LICENSED GENERATORS OF ELECTRICITY

Notice is hereby given that the Minister of Minerals and Energy, in terms of section 5B(2) of the Electricity Act, 1987 (Act No. 41 of 1987), prescribe license fees which shall be payable for the period 1 April 2003 to 31 March 2004 by licensed generators of electricity to fund the operations of the National Electricity Regulator (NER).


