NOTICE REGARDING AMENDMENTS TO THE APPLICATIONS RECEIVED BY THE AUTHORITY IN RESPECT OF FOUR-YEAR COMMUNITY SOUND BROADCASTING LICENCE APPLICATIONS IN GAUTENG PROVINCE

Following the notice published in the Government Gazette No 24746 of 10 April 2003, a notice is hereby given in terms of section 41(3) and 41(5) of the Independent broadcasting Authority Act No 153 of 1993 as amended regarding the amendments to the applications received by the Authority for four year community sound broadcasting licences in Gauteng Province. The applications were received and published in the Government Gazette No 18823 of 3 April 1997.

1. Radio Pretoria

Radio Pretoria would be considered for licence area 18 with frequency 104.2MHz.

2. Radio Goudrif

Radio Goudrif would be considered for frequency 89.1MHz in licence area 26.

3. Radio Springbok

Radio Springbok would be considered for the frequency 102.2MHz in licence area 27.

4. Vaal Community Radio

The Authority would only consider the application by Vaal Community Radio received in terms of Government Gazette No 17998 of May 1997 for the fouryear process in Gauteng Province.

5. Orange Farm Community Radio

The applicant would be considered for frequency 100.6 MHz and licence area 32.

6. Radio Pulpit

Radio Pulpit has withdrawn its applications for four-year community sound broadcasting licence i.e. the application for multiple frequencies across the country and the application for frequency 657 KHz.

7. Radio East Rand

The applicant would be considered for frequency 93.9MHz published in the 1997 frequency plan for Gauteng community radio frequency plan for licence area 24.
