APPLICATION FOR FOUR YEAR COMMUNITY SOUND BROADCASTING LICENCE: WESTERN CAPE PROVINCE.

- **1.** It came to the Authority's attention during consideration of the applications for four year community sound broadcasting licences in the Western Cape Province that the frequency 87.6 MHz. in licence area 51 A as advertised in Government Gazette No17998 dated 9 May 1997 was not available for community sound broadcasting services in the area.
- 2. It further came to the Authority's attention that the application of CCFM for frequency 87.6 MHz in licence area 51 was erroneously not published in the government gazette No 18752 dated 13 March 1998 or subsequent gazette publications as required by the Independent Broadcasting Authority Act 153 of 1993, which indicates the applications received for the province.
- **3.** Voice of the Cape (VOC) and Cape Community FM (CCFM) were the applicants for the frequency 87.6 MHz in licence area 51 A .The particulars of the applications are indicated in the schedule below.





