- 1 (one) social worker elected by social workers from nominations by the social work education and training institutions;
- 1 (one) social worker engaged in full-time or part-time private practice, nominated and elected by social workers; and
- 1 (one) social auxiliary worker nominated and elected by social auxiliary workers.

Nominations of persons who comply with the requirements of regulation 2 of the above mentioned regulations, are invited.

- accept such nomination in writing on the prescribed nomination form or if it is impossible for the nominee to sign the nomination form, he or she may notify the returning officer by letter, fax or e-mail that he/she accepts his/her nomination; and
- deposit with the returning officer an amount of R50.

Any person who is entitled to vote at the election, may sign the nomination form of any number of nominees in the category for which he or she is entitled to vote, but not more than the number of members to be elected in that category.
