**HIGHER EDUCATION ACT, 1997
(ACT No. 101 of 1997)****UNIVERSITY OF PRETORIA
AMENDMENT OF STATUTE**

The Council of the University of Pretoria has made the amendment to the Statute set out in the Schedule hereto, in accordance with section 32 of the Higher Education Act, 1997 (Act No. 101 of 1997), which is, in terms of the provisions of section 33 of the said Act, hereby published with the approval of the Minister of Education and which comes into operation on the date of this publication.

SCHEDULE

1. *In this Schedule the expression "the Statute" means the Statute of the University of Pretoria promulgated by Government Notice No. R1632 of 18 October 199, as amended by Government Notice No. 755 of 10 June 1999..*
2. *The Statute is hereby amended by substituting paragraph 3 for the following paragraph:*
 - "3. (1) The terms of office of all members of the Council whose terms would have expired through effluxion of time during 2003, are extended to 31 December 2003.
 - (2) The terms of office of the Chairperson and Vice-chairperson of the Council are automatically extended to the first Council meeting of 2004.
 - (3) The terms of office of all the members of the Council shall expire on 31 December 2003, except for the following:
 - (i) the Principal;
 - (ii) the Vice-principals;
 - (iii) the six persons appointed by the Council on the basis of their expertise and experience;
 - (iv) the four members of the Convocation of the University, elected by the members of Tuks Alumni;

- (v) the four persons appointed by the Minister of Education in terms of section 27(4)(c) of the Higher Education Act, 1977 (Act No 101 of 1997);
 - (vi) the two persons elected from the ranks of the donors of the University.”.
