NOTICE OF REINSTATEMENT OF PROCESS ON THE NOTICE CONTAINED IN GOVERNMENT GAZETTE NO. 24692 ('THE NOTICE'') SETTING OUT "THE INTENTION TO INCLUDE ANY LICENSEE WITH RELEVANT MARKET SHARE OF AT LEAST 35% OF A DEFINED TELECOMMUNICATIONS MARKET, IN THE CATEGORY OF A MAJOR OPERATOR, IN TERMS OF SECTION 2.4 OF SUPPLEMENTARY INTERCONNECTION GUIDELINES AS PUBLISHED IN GOVERNMENT GAZETTE 24203 DATED 19 DECEMBER 2002"
