The Independent Communications Authority of South Africa (ICASA) gives notice, in accordance with section 52 of the Independent Broadcasting Authority Act, No. 153 of 1993, that an application has been received in terms of section 52 for amendments to Midi TV (Pty) Ltd's broadcasting licence. The amendment if granted, would result in the expansion of e-tv's footprint by way of **14 new self-help relay stations** as set out in the Schedule below.
