The Independent Communications Authority of South Africa hereby gives notice in accordance with the provisions of section 41 (6) of the Independent Broadcasting Authority Act, No. 153 of 1993, as amended, that the following applications have been received in terms of the provisions of Section 52 of the IBA Act for the amendment of a Commercial sound broadcasting licence as set out in the Schedule below.
2. - 6.2.1 P4 Radio Durban (Pty) Ltd. broadcasting as P4 Radio Durban and P4 Radio Cape Town (Pty) Ltd broadcasting as P4 Radio 104.9MHz are both licenced to broadcast 24 hours per day to provide a commercial sound broadcasting service of **Smooth Adult Contemporary Jazz format**. The principal language of broadcast is English.
- 6.2.2 The licences were granted by the Authority in 1997 in terms of Section 46 and Section 54(b) of the Independent Broadcasting Authority Act (Act 153 of 1993 as amended). P4 Radio Durban (Pty) Ltd's commercial licence is due to expire on 05 July 2004 and P4 Radio Cape Town (Pty) Ltd's commercial licence expired in July 2003 and currently waiting for renewal.
