PROCLAMATION

SPECIAL ALLOWANCE OF MEMBERS OF THE NATIONAL ASSEMBLY, PREMIERS, MEMBERS OF THE EXECUTIVE COUNCIL OR MEMBERS OF THE PROVINCIAL LEGISLATURE AND PERMANENT DELEGATES TO THE NATIONAL COUNCIL OF PROVINCES WHOSE TENURE OF OFFICE WAS AFFECTED BY THE GENERAL ELECTION HELD ON 14 APRIL 2004

In terms of section 3(1) and section 6(1) of the Remuneration of Public Office Bearers Act, 1998 (Act No 20 of 1998), I hereby, by means of the accompanying proclamation in English, determine that a once off special allowance equivalent to one month's salary, be paid to an office bearer who, on 13 April 2004-

- (a) was a member of the National Assembly and who was not designated as a representative by the Electoral Commission in terms of section 46 of the Constitution of the Republic of South Africa, 1996 (Act No 108 of 1996) (the Constitution), pursuant to the election of the National Assembly on 14 April 2004,or
- (b) was a permanent delegate to the National Council of Provinces, and who was not re-appointed by the provincial legislature concerned in terms of section 61(2)(b) of the Constitution of the Republic of South Africa, 1996, pursuant to the election of the provincial legislature on 14 April 2004, or

(c) was a Premier, a Member of the Executive Council or a Member of the Provincial Legislature, and who was not designated as a representative by the Electoral Commission in terms of section 105 of the Constitution of South Africa, 1996, pursuant to the election on 14 April 2004.

Provided that, no allowance will be payable in terms of this proclamation to a person who, within one month as from 13 April 2004, is elected or appointed to any office under the State and receives or will receive remuneration for serving in that office.

The level of remuneration of the special allowance shall be determined in accordance with the salary scales applicable in respect of the office bearers referred to above as at 13 April 2004.
