AMENDMENT OF THE RULES REGULATING THE CONDUCT OF THE PROCEEDINGS OF THE ORANGE FREE STATE PROVINCIAL DIVISION OF THE HIGH COURT OF SOUTH AFRICA

Notice is hereby given that the Judge President of the Orange Free State Provincial Division of the High Court of South Africa has, in terms of section 43(2)(b)(i) of the Supreme Court Act, 1959, (Act No. 59 of 1959), amended Rule 2 of the Rules regulating the conduct of proceedings of the said Court, published under Government Notice No. R. 3290 of 12 September 1969, and in which subrule (1) was substituted by Government Notice No. 904 of 10 July 1998, by substituting the existing subrule (1) with the following new subrule (1):

TERMS:






