#### APPLICATION FOR THE RENEWAL OF A FOUR YEAR BROADCASTING LICENCE CONDITIONS: MOHODI COMMUNITY RADIO STATION

1. The Independent Communications Authority of South Africa ("the Authority") hereby gives notice, in terms of the provisions of section 44(2) of the Independent Broadcasting Authority Act, No 153 of 1993, as amended, that it has received an application from Mohodi Community Radio for the renewal of its community sound broadcasting licence in terms of section 44(1). The details of the application are contained in the schedule below.
2. The application is available and open for inspection by interested persons in the Authority's library during the Authority's normal office hours.
3. Interested persons are invited to lodge written representations in relation to the application by no later than 28 August 2004. 4. Persons who lodge representations in terms hereof must simultaneously indicate whether they also require an opportunity to make oral representations to the Authority.

Persons who lodge representations in terms hereof, shall at the time of lodgement furnish proof to the satisfaction of the Authority that a copy of the representation has been delivered by hand to Mr MD Manthata, Station Manager, Mohodi Community Radio Station, 62B Newstand, Mohodi- HA- Manthata 0788 or sent by registered post to PO Box 7111, Manthata, 0788 or faxed to (015/ 505 0013.
6. Mohodi Community Radio shall be entitled to respond in writing to written representations made by interested persons on the proposed renewal, and such written response must be lodged with the Authority within sixty (60) days of the date of publication of this notice in the *Government Gazette*. Mohodi Community Radio must, at the time of lodging such written response, furnish proof to the Authority's satisfaction that it has delivered a copy of such response by hand, or has sent a copy of such response by registered mail or by facsimile to the relevant person having made such written representations.
