**NOTICE 1744 OF 2004****INDEPENDENT COMMUNICATIONS AUTHORITY OF SOUTH AFRICA****APPLICATION FOR THE AMENDMENT OF LICENCE CONDITIONS: KAYA FM**

1. The Independent Communications Authority of South Africa (ICASA) wishes to amend **Government Gazette number 26476, Notice number 468 of 15 June 2004**, which notified the public of an application by Kaya FM in terms of section 52(1) (C) of the Independent Broadcasting Authority Act 153 of 1993 ("the Act") to amend its licence conditions by increasing its coverage area.
2. The amendment to the abovementioned notice is as a result of amendments submitted by Kaya FM to their original application. The new amendment proposals are set out in the schedule below.
3. The proposed amendments are available at the Authority's library for inspection by any interested parties during the Authority's normal office hours.
4. Interested persons are hereby invited to make written representations on the proposed amendment to the Authority by **3 September 2004**. Interested persons who make such written representations to the Authority must simultaneously indicate whether they require an opportunity to make oral representations to the Authority on the proposed amendments.

5. All written representations, responses and other correspondence regarding the proposed amendment must be directed to Mr. Thabo Ndhlovu, Manager: Licensing at Block D, Pinmill Farm, 164 Katherine Street, Sandton, Johannesburg or Private Bag X10002, Sandton, 2146 or by fax (011) 448 2186.
6. Persons, who lodge representations in terms hereof, shall at the time of lodgement furnish proof to the satisfaction of the Authority that a copy of the representation has been sent by registered post or delivered or faxed to Ms Charlene Deacon at No. 38 Bolton Road, Rosebank or Fax no. 011 442 5570.
7. Kaya FM shall be entitled to respond in writing to the written representations made by interested persons on the proposed amendments, and any such written response must be submitted to the Authority within sixty (60) days of the date of publication of this notice in the *Government Gazette*. Kaya FM must, at the time of submitting its written response, furnish proof to the Authority's satisfaction that it has delivered a copy of the response by hand, or has sent a copy of the response by registered mail or by facsimile, to the relevant persons having made written representations.
