NOTICE 175 OF 2004



APPLICATION FOR THE AMENDMENT OF LICENCE CONDITIONS: RADIO KRAGBRON

1. **The Independent Communications Authority of South Africa ("the Authority") hereby gives notice, in terms of the provisions of section 52(2) of the Independent Broadcasting Authority Act, No 153 of 1993, as amended, that it has received an application from Radio Kragbron for the amendment of its community sound broadcasting licence in terms of section 52(1)(c) of the Act.**
2. The amendment sought is to allow Radio Kragbron to install gap filler at its broadcasting studio in order to improve coverage of its reception area in mainly Witbank/ Emalahleni Central area. The details of the application are contained in the schedule below.
3. The application is available and open for inspection by interested persons in the Authority's library during the Authority's normal office hours.
4. **Interested persons are invited to lodge written representations in relation to the application by no later than 6 September 2004.** Interested persons who make such representations to the Authority must simultaneously indicate whether they require an opportunity to make oral representations to the Authority on the proposed amendments.
5. All written representations, responses and other correspondence must be directed to Victor Grootboom at The Licensing Unit, Broadcasting Division, Independent Communications Authority of South Africa at Block D, Pinmill Farm, 164 Katherine Street, Sandton, Johannesburg or Private Bag x 10002, Sandton, 2146 or by fax no. 6. Persons who lodge representations in terms hereof, shall at the time of lodgement furnish proof to the satisfaction of the Authority that a copy of the representation has been delivered by hand to Mr. Hennie Smit, Station Manager, Radio Kragbron, 56 Andromeda Street, Reynoridge, Witbank or sent by registered post to P.O. Box 8928, Die Heuwel, Witbank, 1042 or faxed to (013) 697 1195.

7. Radio Kragbron shall be entitled to respond in writing to written representations made by interested persons on the proposed renewal, and such written response must be lodged with the Authority within sixty (60) days of the date of publication of this notice in the *Government Gazette*. Radio Kragbron must, at the time of lodging such written response, furnish proof to the Authority's satisfaction that it has delivered a copy of such response by hand, or has sent a copy of such response by registered mail or by facsimile to the relevant person having made such written representations.
