APPLICATION FOR THE AMENDMENT OF BROADCASTING LICENCE CONDITIONS:

MIDI TV (PTY) LTD

1. The Independent Communications Authority of South Africa ("the Authority") hereby gives notice, in terms of the provisions of section 52(2) of the Independent Broadcasting Authority Act, No 153 of 1993, as amended, that it has received an application in terms of section 52 (1) (c) from Midi TV (Pty) Ltd for the amendment of Schedule B of its current licence conditions.
2. The amendment is sought to enable the licensee to establish self-help stations that will carry etv's television services as set out in the schedule attached.
3. The application is available at the Authority's library for inspection by any interested parties during the Authority's normal office hours.
4. Interested parties are invited to make written representations on the proposed amendments to the Authority by 23 September 2004. Interested persons who make such representations to the Authority must simultaneously indicate whether they require an opportunity to make oral representations to the Authority on the proposed amendments.

7. Midi TV (Pty) Ltd shall be entitled to respond in writing to the written representations made by interested persons on the proposed amendments, and such written response must be submitted to the Authority within sixty (60) days of the date of publication of this notice in the *Government Gazette*. Midi TV (Pty) Ltd must, at the time of submitting its written response, furnish proof to the Authority's satisfaction that it has delivered a copy

of such response by hand, or has sent a copy of such response by registered mail or by facsimile to the relevant person having made written representations.
