A person to be nominated must:

- Be a fit and proper to hold office as a member
- Have appropriate qualifications and experience in the field of biodiversity.

A person holding office as a member of Parliament, a provincial legislature or a municipal council may not be appointed as member of the Governing Board of SANBI. Successful candidates will be appointed in their personal capacities on a part time basis for a pre-determined period not exceeding three years. Members of the Board are paid such remuneration and allowances as the Minister, with the concurrence of the Minister of Finance, may determine.
