4. Persons who lodge representations in terms hereof must simultaneously indicate whether they also require an opportunity to make oral representations to the Authority.

Persons who lodge representations in terms hereof, shall at the time of lodgement furnish proof to the satisfaction of the Authority that a copy of the representation has been delivered by hand to Ms L Sono, Station Manager, Letlhabile Community Radio, House No. 3968 Zone 2, Letlhabile 0264 or sent by registered post to PO Box 688 Letlhabile, 0264 or faxed to (012) 251 3995.
6. Letlhabile Community Radio shall be entitled to respond in writing to written representations made by interested persons on the proposed renewal, and such written response must be lodged with the Authority within sixty (60) days of the date of publication of this notice in the *Government Gazette*. Letlhabile Community Radio must, at the time of lodging such written response, furnish proof to the Authority's satisfaction that it has delivered a copy of such response by hand, or has sent a copy of such response by registered mail or by facsimile to the relevant person having made such written representations.
