# NOTICE OF HEARINGS FOR THE SOUTH AFRICAN BROADCASTING CORPORATION'S (SABC'S) APPLICATION FOR TWO REGIONAL TELEVISION SERVICES IN TERMS OF SECTION 22A OF THE BROADCASTING ACT

- 1. The Independent Communications Authority of South Africa hereby gives notice in accordance with the provisions of section 42 (2) of the Independent Broadcasting Authority Act, 153 of the 1993 as amended, that hearings will be conducted in respect of the SABC's application in terms of section 22A of the Broadcasting Act, 4 of 1999, as amended, for two Regional Television Services namely SABC 4 and SABC 5. The applicant proposes a service which will encourage the development of South African expressions by catering for all official languages in terms of the Charter as it appears in chapter 4 of the Broadcasting Act, 1999. The service will, according to the applicant, present the public broadcaster and the citizens it serves with the possibility of show casing content that informs, educates and entertains in a fuller, more relevant and meaningful way than the existing platforms have allowed.
- The hearings will take place in the Limpopo Province on 5 October 2004 and in the Western Cape on 18 October 2004 as per the schedule below.
