INVITATION FOR PUBLIC COMMENTS ON THE RESEARCH PROPOSALS REGARDING THE RENEWAL OF CERTIFICATE OF ESTABLISHMENT OF SETAS

I, Membathisi Mphumzi Shepherd Mdladlana, Minister of Labour, have on 20 March 2000 in terms of section 9 (1) of the Skills Development Act, 1998 established the Sector Education and Training Authorities as set out in Government Gazette No. 21012 of 20 March 2000.

Stakeholders are invited to comment on the commissioned research that is proposing the retention of the following 11 SETAs with minor adjustment to their scope of coverage.

- 1. CHIETA Chemical Industries Sector
- 2. HWSETA Health & Welfare Sector
- 3. FOODBEV Food & Beverage Sector
- 4. MQA Mining Sector
- 5. CTFLSETA Textiles and Footwear Sector
- 6. ISETT Information & Telecommunications Sector
- 7. Services SETA Personal & Business Services Sector
- 8. CETA Construction Sector
- 9. W&RSETA Wholesale & Retail Sector
- 10. ETDPSETA Education and Training Sector
- 11. TETA Transport Sector

Stakeholders are invited to comment on the commissioned research that is proposing the following amongst predominantly private sector SETAs:

That MERSETA, the current manufacturing SETA be split into two SETAs namely:

- 12. MERSETA a proposed steel based manufacturing and auto manufacturing activities SETA and
- 13. MANSETA a new proposed SETA catering for all non-steel based manufacturing activities that could incorporate the current printing and packaging manufacturing activities of the Media SETA (MAPPP) and the manufacturing operations of the Forestry SETA (FIETA).

That two leisure activity SETAs be considered for re-establishment and establishment.

- 14. THETA The retention of the current Tourism and Hospitality SETA (THETA) but excluding sporting activities
- 15. SCARETA Establishment of a new Sport, Creative, Arts and Recreation activities SETA that could incorporate all media and advertising activities from MAPPP and Sport Activities from THETA.

That a single consolidated agricultural resource activity SETA be considered for re-establishment:

16. AFFSETA – A proposed new Agriculture, Forestry and Fishing Activities SETA that could incorporate the current Primary Agriculture (PAETA); secondary Agriculture (SETASA) and the plantation activities of the Forestry SETA (FIETA) but exclude their manufacturing aspects.

That a single consolidated financial investment services activity SETA be considered for re-establishment.

17. FBISETA – A proposed new Finance, Banking and Insurance activities SETA that could arise from mergers of the current BANK SETA; Finance (FASSET) and Insurance INSETA).

Stakeholders are invited to comment on the commissioned research that is proposing the following amongst the predominantly public sector SETAs:

That a single consolidated public safety activities SETA be considered for re-establishment.

18. POSLECSETA – Retention of the current Police and Security SETA (POSLEC) with some adjustments that could incorporate parts of the Diplomacy, Defence and Intelligence SETA (DIDTETA) being Defence, National Intelligence and Secret Services

That a single consolidated public services SETA be considered for reestablishment.

19. PSETA- The retention of the current Public Services SETA (PSETA) that could incorporate the diplomacy, foreign affairs, trade and industry activities from DIDTETA. This new PSETA could incorporate the Local Government SETA (LGWSETA) excluding the Water related activities.

That a single consolidated Energy SETA be considered for re-establishment.

20. EWSETA – The retention of the current Energy SETA (ESETA) that could incorporate the water related activities from the LGWSETA.
