The South African Qualifications Authority (SAQA) hereby notifies the public that, after a voluntary process by the SAIMH, and the development of a proper implementation plan, it intends to de-accredit SAIMH for the qualifications registered on the NQF and listed below:

The South African Qualifications Authority (SAQA) further notifies the public that it intends to extend the accreditation of the TETA to include the following qualifications:

Materials Handling	Level 4

All providers currently accredited by the SAIMH, and all learners currently registered on any of the above qualifications, will with immediate effect be placed on the data base of the TETA, and be quality assured by the TETA as part of the implementation plan.

Objections to the de-accreditation of the above SAIMH ETQA, and the extension of accreditation of the TETA ETQA must be lodged with the Executive Officer of SAQA by 9th December 2004.
