APPLICATION FOR THE RENEWAL OF A FOUR YEAR COMMUNITY SOUND BROADCASTING LICENCE: KHANYA COMMUNITY RADIO

1. The Independent Communications Authority of South Africa ("the Authority") hereby gives notice, in terms of the provisions of section 44(2) of the Independent Broadcasting Authority Act, No 153 of 1993, as amended, that it has received an application from Khanya Community Radio for the renewal of its community sound broadcasting licence in terms of section 44(1). The details of the application are contained in the schedule below.
2. The application is available and open for inspection by interested persons in the Authority's library during the Authority's normal office hours.
3. Interested persons are invited to lodge written representations in relation to the application by no later than 08 December 2004. 4. Persons who lodge representations in terms hereof, must simultaneously indicate whether they also require an opportunity to make oral representations to the Authority.

Persons who lodge representations in terms hereof, shall at the time of lodgement furnish proof to the satisfaction of the Authority that a copy of the representation has been delivered by hand to Mr Keith Vutula, Station Manager, Khanya Community Radio, No. 59 Blythe Street, Butterworth 4960 or sent by registered post to PO Box 1166 Butterworth 4960 or faxed to (047) 491 0466.
6. Khanya Community Radio shall be entitled to respond in writing to written representations made by interested persons on the proposed renewal, and such written response must be lodged with the Authority within sixty (60) days of the date of publication of this notice in the *Government Gazette*. Khanya Community Radio must, at the time of lodging such written response, furnish proof to the Authority's satisfaction that it has delivered a copy of such response by hand, or has sent a copy of such response by registered mail or by facsimile to the relevant person having made such written representations.
