The Independent Communications Authority of South Africa ("the Authority") hereby gives notice, in terms of the provisions of section 44(2) of the Independent Broadcasting Authority Act, No 153 of 1993, as amended, that it has received an application from Ilitha Community Radio for the renewal of its community sound broadcasting licence in terms of section 44(1). - Persons who lodge representations in terms hereof, must simultaneously indicate whether they also require an opportunity to make oral representations to the Authority.

Persons who lodge representations in terms hereof, shall at the time of lodgement furnish proof to the satisfaction of the Authority that a copy of the representation has been delivered by hand to Ms Nompumelelo Totongwana, Station Manager, Ilitha Community Radio, No. 1813 Peter Mokaba Park, Maclear 5480 or sent by registered post to PO Box 221, Maclear 5480 or faxed to (045) 932 1242.
- 6. Ilitha Community Radio shall be entitled to respond in writing to written representations made by interested persons on the proposed renewal, and such written response must be lodged with the Authority within sixty (60) days of the date of publication of this notice in the Government Gazette. Ilitha Community Radio must, at the time of lodging such written response, furnish proof to the Authority's satisfaction that it has delivered a copy of such response by hand, or has sent a copy of such response by registered mail or by facsimile to the relevant person having made such written representations.
