## DRIED FRUIT INDUSTRY REQUESTING COMMENTS IS ON THE APPLICATION OF A NEW TERM OF STATUTORY MEASURES IN THE DRIED FRUIT INDUSTRY

It is hereby made known in terms of section 11 of the Marketing of Agricultural Products Act, 1996 (Act No. 47 of 1996), that the Minister of Agriculture has received a request for the implementation of statutory measures in terms of section 10 and 11 of the said Act.

Dried Fruit Technical Services (DFTS), a company incorporated under section 21 of the Companies Act 1973, applied for a new term of statutory measures in terms of section 10 and 11 of the Marketing of Agricultural Products Act, Act No. 47 of 1996.

The requested new term are for the following statutory measures:

- Payment of levies by packers or imported by a packer/processor or produced by a producer
- Keeping of Records and Returns by importers, packers, exporters and processors of dried fruit
- Registration with the DFTS by importers, packers, exporters and processors of dried fruit

If approved the payment of levies are to finance the following:

- Information and communication
- Research technology development
- Transformation and training
- International liaison
- Administration

The levy amounts would be as follows

- 4c/kg for dried vine fruit (raisins, seedless raisins, sultanas and currants (currants = seedless currant type vine fruit))
- 8c p/kg for dried apricots, apples, peaches
- 7c p/kg nectarines, pears, prunes and other dried fruits excluding VAT

Currently the following statutory measures are due to expire on 31 March 2005:

- · Payment of levies bought or received by packers:
  - 4c/kg for dried vine fruit (raisins, seedless raisins, sultanas and currants (currants = seedless currant type vine fruit))
  - 6c p/kg for dried apricots, apples, nectarines, pears, peaches, prunes and excluding VAT
- Keeping of Records and Returns by importers, packers, exporters and processors of dried fruit

 Registration with the DFTS by importers, packers, exporters and processors of dried fruit

<u>Directly affected groups</u> in the deciduous fruit industry are hereby <u>invited</u> to forward any comments regarding the proposed statutory measures to the National Agricultural Marketing Council <u>within 14 days</u> of the publication hereof.

In terms of the Standards Act, 1993 (Act No. 29 of 1993), the Council of the South African Bureau of Standards has acted in regard to standards in the manner set out in the Schedules to this notice.

All South African standards that were previously published by the South African Bureau of Standards with the prefix "SABS" have been redesignated as South African National Standards and are now published by Standards South Africa (a division of SABS) with the prefix "SANS".

A list of all existing South African National standards was published by Government Notice No. 1373 of 8 November 2002.

## NOTICE OF INITITATION OF AN INVESTIGATION INTO THE ALLEGED DUMPING OF WHEAT FLOUR ORIGINATING IN OR IMPORTED FROM INDIA

The International Trade Administration Commission of South Africa (the Commission) received an application alleging that wheat flour originating in or imported from India is being dumped on the Southern African Customs Union (SACU) market, threatening to cause material injury to the SACU industry concerned.

#### THE APPLICANT

The Application was lodged by the National Chamber of Milling (NCM) on behalf of its members, which include Tiger Milling, Pioneer Sasko and Premier Foods being the major domestic manufacturers of the product under investigation in the SACU. The Applicant alleges that it cannot compete with the low prices charged by the importers and that the allegedly dumped products are threatening to cause material injury. The Applicant submitted sufficient evidence and established a *prima facie* case to enable the Commission to arrive at a reasonable conclusion that an investigation should be initiated on the basis of dumping, threat of material injury and causality.

#### THE PRODUCT

The product allegedly being dumped is wheat flour, classifiable under tariff subheading 1101.00, originating in or imported from India.

#### THE ALLEGATION OF DUMPING

The allegation of dumping is based on the comparison between the normal value in and the export price from India. The normal value for India is based on the actual purchase invoices. The export price was determined based on the official import statistics obtained from the South African Revenue Service. On this basis, the Commission found that there was *prima facie* proof of dumping.

#### THE ALLEGATION OF THREAT OF MATERIAL INJURY

The Applicant alleges and submitted sufficient evidence to show that there has been a substantial increase in the volume of alleged dumped imports at prices which will have a suppressing effect on domestic prices. It further alleges that stock piling of wheat production of up to 9 months consumption has been taking place in India, the cost of which has become burdensome. Therefore, a threat of material injury exists in that the excess stock could be exported at dumped prices which will cause material injury.

On this basis the Commission found that there was *prima facie* proof of threat of material injury and causal link.

#### PERIOD OF INVESTIGATION

The period of investigation for dumping will be from 1 May 2003 to 30 April 2004. The period of investigation for purposes of determining injury will be from 1 May 2001 to 30 April 2004.

#### PROCEDURAL FRAMEWORK

Having decided that there is sufficient evidence and a *prima facie* case to justify the initiation of an investigation, the Commission has begun an investigation in terms of section

16 of the International Trade Administration Act, 2002 (the ITA Act). The Commission will conduct its investigation in accordance with the relevant sections of the ITA Act, the World Trade Organisation Agreement on Implementation of Article VI of the GATT 1994 (the Anti-Dumping Agreement) and the Anti-Dumping Regulations of the International Trade Administration Commission of South Africa (ADR). Both the ITA Act and the ADR are available on the Commission's website (<a href="www.itac.org.za">www.itac.org.za</a>) or from the Trade Remedies section, on request.

In order to obtain the information it deems necessary for its investigation, the Commission will send non-confidential versions of the petition and questionnaires to all known importers and exporters, and known representative associations. The trade representative of the exporting country have also been notified. Importers and other interested parties are invited to contact the Commission as soon as possible in order to determine whether they have been listed and were furnished with the relevant documentation. If not, they should immediately ensure that they are sent copies. The questionnaire has to be completed and any other representations must be made within the time limit set out below.

#### PROCEDURES AND TIME LIMITS

All responses, including non-confidential copies of the responses, should be received by the Director: Trade Remedies I not later than 30 days from the date hereof, or from the date on which the letter accompanying the abovementioned questionnaire was received. The said letter shall be deemed to have been received seven days after the day of its dispatch.

Late submissions will not be accepted except with the prior written consent of the Commission. The Commission will give due consideration to written requests for an extension of not more than 14 days on good cause shown (properly motivated and substantiated), if received prior to the expiry of the original 30-day period. Merely citing insufficient time is not an acceptable reason for extension. Please note that the Commission will not consider requests for extension by the Embassy on behalf of the exporter.

The information submitted by any party may need to be verified by the Investigating Officers in order for the Commission to take such information into consideration. It is planned to do the verification of the information submitted by the exporters within three to five weeks subsequent to submission of the information. This period will only be extended if it is not feasible for the Commission to do it within this time period or upon good cause shown, and with the prior written consent of the Commission, which should be requested at the time of the submission. It should be noted that unavailability of, or inconvenience to consultants will not be considered to be good cause. Parties should also ensure when they engage consultants that they will be available at the requisite times, to ensure compliance with the above time frames. Parties should also ensure that all the information requested in the applicable questionnaire is provided in the specified detail and format. The questionnaires are

designed to ensure that the Commission is provided with all the information required to make a determination in accordance with the rules of Anti-Dumping Agreement. The Commission may therefore refuse to verify information that is incomplete or does not comply with the format in the questionnaire, unless the Commission has agreed in writing to a deviation from the required format. A failure to submit an adequate non-confidential version of the response that complies with the rules set out above under the heading Confidential Information will be regarded as an incomplete submission.

Parties who experience difficulty in furnishing the information required, or submitting in the format required, are therefore urged to make written applications to the Commission at an early stage for permission to deviate from the questionnaire or provide the information in an alternative format that can satisfy the Commission's requirements. The Commission will give due consideration to such a request on good cause shown.

Any interested party may request an oral hearing at any stage of the investigation in accordance with Section 5 of the ADR, provided that the party indicates reasons for not relying on written submission only. The Commission may refuse an oral hearing if granting such hearing will unduly delay the finalisation of a determination. Parties requesting an oral hearing shall provide the Commission with a detailed agenda for, and a detailed version, including a non-confidential version, of the information to be discussed at the oral hearing at the time of the request. Oral representations will be limited to one hour for SACU manufacturers and exporters and thirty minutes for importers.

If the required information and arguments are not received in a satisfactory form within the time limit specified above, or if verification of the information cannot take place, the Commission may disregard the information submitted and make a finding on the basis of the facts available to it.
