

The UACs are Johannesburg Water (Pty) Ltd, City Power Johannesburg (Pty) Ltd, Pikitup Johannesburg (Pty) Ltd, Johannesburg Roads Agency (Pty) Ltd, Johannesburg City Parks (Pty) Ltd, the Johannesburg Zoo, Johannesburg Metropolitan Bus Services (Pty) Ltd, Johannesburg Property Company (Pty) Ltd and Johannesburg Fresh Produce Market (Pty) Ltd.
4. The CCMA has been called upon to determine whether:
  - 4.1 any UAC, employee employed in any UAC, is or was employed or engaged in the municipal services sector (i.e. the registered scope of the SALGBC);
  - 4.2 any provision in any agreement concluded under the auspices of the SALGBC is or was binding on any UAC or any employee by a UAC.
5. The registered scope of the SALGBC is the local government undertaking in the Republic of South Africa which is defined by the SALGBC Constitution to mean "... the undertaking in which the employer and employees are associated for the institution, continuance, and finalisation of any act, scheme, or activity normally undertaken by a Municipality".

It is hereby notified that the following amendments to the Rules framed in terms of Section 74(1) of Act No. 53 of 1979 and which have been approved by the Chief Justice of South Africa in consultation with the Judge President of the Transvaal in terms of Section 74(2) of Act No. 53 of 1979, are promulgated by the Council of the Law Society of the Transvaal:

The following changes are made to the existing rules (underlined portions of the rules which are in bold print, are new and the words in brackets are to be deleted from the existing rules):

#### **Rule 30A**

"30A.1 The council shall consist of (twenty) ~~twenty-four~~ persons being members, but of whom no more than two may be declared members.

Of such (twenty) ~~twenty-four~~ members-

30A.1.1 not more than (four) ~~three~~ in number shall-

30A.1.1.1 where they are practising members, have their principal places of practice; and

30A.1.1.2 where they are declared members, have their places of abode,  
**in the Magisterial Districts of Johannesburg / Randburg;**

30A.1.2 not more than two in number shall-

30A.1.2.1 where they are practising members, have their principal places of practice; and

30A.1.2.2 where they are declared members, have their places of abode,  
**in the Magisterial Districts of Pretoria / Wonderboom;**

30A.1.3 not more than one in number shall-

30A.1.3.1 where he/she is a practising member, has his/her principal place of practice; and

30A.1.3.2 where he/she is a declared member, has his/her place of abode,  
**in the remainder of the Province of Gauteng (excluding the Magisterial Districts referred to in 30A.1.1.2 and 30A.1.2.2)**

30A.1.(2)~~4~~ not more than two in number shall-

30A.1.(2)~~4~~.1 where they are practising members, have their principal places of practice; and

- 30A.1.(2)~~4~~.2 where they are declared members, have their places of abode, respectively in each of the (Northern) **Limpopo** Province, the North West Province and the Province of Mpumalanga;
- 30A.1.(3)~~5~~ not more than (five) **six** in number shall-
- 30A.1.(3)~~5~~.1 where they are practising members, have their principal places of practice; and
- 30A.1.(3)~~5~~.2 where they are declared members, have their places of abode, within the area of jurisdiction of the Society, and shall be members in good standing of the Black Lawyers' Association; and
- 30A.1.(4)~~6~~ not more than (five) **six** in number shall-
- 30A.1.(4)~~6~~.1 where they are practising members, have their principal places of practice; and
- 30A.1.(4)~~6~~.2 where they are declared members, have their places of abode, within the area of jurisdiction of the Society, and shall be members in good standing of the National Association of Democratic Lawyers."

#### **Rule 47**

"47. In making an appointment to the council-

- 47.1 to fill a vacancy caused by the vacation of office by a member of the council in terms of Section 62(2)(a) of the Act; or
- 47.1.1 to fill a vacancy caused by the increase in the number of the members of the council in terms of Section 62(2)(b) of the Act; or
- 47.2 to act in the place of a suspended member of the council in terms of Section 62(3) of the Act; or
- 47.3 by co-operation in terms of rule 32.2, rule 32.3 or rule 38.4;

the council shall ensure that the allocation of seats on the council is maintained (at) **as provided for in terms of rule 30.1, or alternatively rule 30A.**

Rules 47.4, 47.5, 47.6 and 47.7 are hereby repealed."
