Projected life	The project will be completed in the 2007/08 financial year depending on the request for funding by the Gauteng Department of Housing.
Payment schedule	Annual payment on 15 December 2004.
Capacity and preparedness of the transferring department	• The national Department of Land Affairs to ensure that the funds are used for land acquisition in terms of the standard agreement and that the land is used for resettlement in terms of the land redistribution programme.
	• Ensure that the land will benefit beneficiaries in terms of Act 126 of 1993.
