SEA FISHERY ACT, 1988 (ACT NO. 12 OF 1988)

LEVIES ON FISH AND FISH PRODUCTS

I, Mohammed Valli Moosa, Minister of Environmental Affairs and Tourism, acting with the concurrence of the Minister of Finance, hereby under Section 29 of the Sea Fishery Act, impose the levies on fish and fish products as set out in the Schedule.

SCHEDULE

1. In this Schedule any word or expression to which a meaning has been assigned to in the Act, shall bear the meaning so assigned to it and, unless the context otherwise indicates—

"**abalone**" means any shellfish of the species *Haliotis midae*, also known as "perlemoen";

"**anchovy**" means any fish of the species *Engraulis capensis*;

"**east coast crustacean**" means any crustacean, including shrimps, prawns and langoustines found in the waters of the Province of KwaZulu-Natal and caught by means of bottom trawl nets;

"**east coast sole**" means any fish of the species *Austroglossus pectoralis*;

"**hake**" means any fish of the genus *Merluccius*;

"**horse-mackerel**" means any fish of the species *Trachurus trachurus capensis*;

"**kingklip**" means any fish of the species *Genypterus capensis*;

"**langoustine**" means any crustacean of the species *Metanephrops mozambicus* (previously known as *Metanephrops anadamanicus*);

"**monkfish**" means any fish of the species *Lophius vomerinus*;

"**pilchard**" means any fish of the species *Sardinops sagax*;

"**redeye or round herring**" means any fish of the species *Etrumeus whiteheadi*;

"**red spotted sole**" or "**red spotted tonguefish**" or "**sandrat**" means any fish of the

species *Cynoglossus zanzibarensis*;

"ribbonfish" means any fish of the species *Lepidopus caudatus*;

"seaweed" means any marine macro-algae, including Kelp [*Ecklonia maxima* and *Laminaria pallida* (*including Laminaria Schinzii*)] and other species such as *Gracilaria gracilis*, *Gracilaropsis spp.* and *Gelidium spp.*;

"shark" means any fish of the class *Chondrichthyes*.

"shrimp" means any crustacean of the superfamilies Caridea and Penaeoidea including genera *Callianassa* and *Upogebia*;

"snoek" means any fish of the species *Thyrsites atun*;

"south coast rock lobster" means any rock lobster of the species *Palinurus gilchristi*;

"squid" means any squid or chokka squid *Loligo vulgaris reynaudii*;

"the Act" means the Sea Fishery Act, 1988 (Act No. 12 of 1988);

"tuna" means the species *Allothunnus fallai*, *Euthynnus affinis*, *Gymnosarda unicolor*, *Katsuwonus pelamis*, *Sarda orientalis* or *Sarda sarda* or any species of the genus *Thunnus*

"west coast rock lobster" means any Cape or spiny rock lobster of the species *Jasus lalandii*;

"west coast sole" means any fish of the species *Austroglossus microlepis*.

2. Subject to paragraph 3 –

A holder of a right to undertake commercial fishing of pelagic fish (pelagic bait included) shall pay the following levy per ton whole mass fish caught:

R46.00 for directed pilchard and R13.00 for anchovy, pilchard bycatch as well as for all other fish caught for industrial purposes;

3. For the purposes of paragraph 2, the mass of pilchard, anchovy, redeye (round herring) and horse mackerel shall be determined at a fish processing establishment in the presence of a fishery control officer (subject to paragraph 15).
4. A holder of a right to undertake commercial fishing of west coast rock lobster shall pay a levy of R3744.00 per ton whole mass of west coast rock lobster received/caught (subject to paragraph 15).

5. A holder of a right to undertake commercial fishing of south coast rock lobster shall pay a levy of R3126.00 per ton whole mass or a levy of R6947.00 per ton tail mass south coast rock lobster caught.
6. Subject to paragraph 15, a person who is the holder of a right to undertake commercial fishing by means of bottom trawl or midwater trawl nets shall pay the following levy per ton whole mass caught:

Hake caught in the offshore trawl and midwater trawl fisheries: R181.00, hake caught in the inshore trawl fishery: R171.00, sole: R276.00, kingklip: R280.00, horse mackerel: R15.00, squid: R342.00, east coast crustaceans: R135.00, monkfish: R184.00, ribbonfish: R18.00 and snoek: R21.00.

7. A holder of a right to undertake commercial fishing of abalone shall pay a levy of R25 000.00 per ton whole mass of abalone caught or received.
8. Subject to paragraph 15, a holder of a right to undertake commercial fishing of traditional linefish shall pay the following levies (fixed payment per category) on whole mass of fish caught:

Two or less than two tonnes	R129.00
Five tonnes and less, but more than two tonnes	R452.00
Ten tonnes and less, but more than five tonnes	R969.00
20 tonnes and less, but more than 10 tonnes	R1936.00
30 tonnes and less, but more than 20 tonnes	R3228.00
More than 30 tonnes	R4518.00

9. A holder of a right to undertake commercial fishing of tuna (pole and line method) shall pay a levy of R118.00 per ton whole mass of tuna caught. The levies payable by holders of rights to undertake tuna or swordfish by means of a longline remain the same as published in Government Notice No.27067, dated 8 December 2004.

10. A holder of a right to undertake commercial fishing of shark by means of a longline shall pay a levy of R118.00 per ton whole mass of shark caught (subject to paragraph 15).

11. A holder of a right to undertake commercial fishing of hake by means of a longline shall pay a levy of R181.00 per ton whole mass of hake caught, as well as a levy of R280.00 per ton whole mass of kingklip caught (subject to paragraph 15).

12. A holder of a right to undertake commercial fishing of hake by means of a handline shall pay a levy of R135.00 per ton whole mass of hake caught (subject to paragraph 15).

13. The holder of a right to undertake commercial fishing of squid shall pay a levy of R342.00 per ton whole mass of squid caught.

14. A holder of a right to undertake commercial harvesting of seaweed shall pay a levy of R95.00 per dry ton kelp (*Laminaria pallida* [including *laminaria schinzii*] and *Ecklonia maxima*) and R207.00 per dry ton of all other seaweed species as described in paragraph 1, gathered.

15. For the purposes of paragraphs 3, 4, 6, 8, 10, 11 and 12 the whole mass of fish shall be determined by multiplying the mass of the fish caught or parts thereof (see column 1 below) with the appropriate conversion factor (see below).

16. The levies payable in respect of fish caught during any one month shall be paid before the end of the following month, except in the case of traditional linefish (paragraph 8) where the levies will be paid before 31 December of the relevant year (based on the permit holders own catch returns). If necessary, in the case of traditional linefish, adjustments in respect of the levies payable will be made in the following year, and permit holders will be allowed to pay the adjusted levies on or before 30 June of the following year.
17. All payments of levies shall be accompanied by a form, certified by the holder of the right to undertake commercial fishing, that indicates the whole mass of fish caught or received during the month (or months in the instance of linefishing) concerned. This form is obtainable from : Marine and Coastal Management, 6th Floor, Foretrust Building, Martin Hammerschlag Road, Foreshore, Cape Town, 8001 / Private Bag X2, Roggebaai, 8012.
18. Interest at the rate determined by the Treasury from time to time, shall be imposed on any outstanding amount, and such interest shall be calculated from the first day of the month following the month in which the fish is landed (except in the case of linefish, where it will be calculated from the first day of the year following the year in which the fish is landed).

19. Levies and interest payable in terms of this Schedule, shall be paid to : Marine and Coastal Management, 6th Floor, Foretrust Building, Martin Hammerschlag Road, Foreshore, Cape Town, 8001 / Private Bag X2, Roggebaai, 8012.
20. Any person who contravenes or fails to comply with any provision of this notice shall be guilty of an offence and liable on conviction to a fine not exceeding R50 000 or to imprisonment for a period not exceeding six years, or to both such fine and such imprisonment.
21. Government Notice No.26195, dated 31 March 2004, is hereby repealed.
22. This notice takes effect on 1 April 2005.

Ek, Mohammed Valli Moosa, Minister van Omgewingsake en Toerisme, handelende met die instemming van die Minister van Finansies, lê kragtens artikel 29 van die Wet op Seevisserij, 1988 (Wet No. 12 van 1988), die heffings ten opsigte van vis en visprodukte op soos in die Bylae uiteengesit.

1. In hierdie Bylae het 'n woord of uitdrukking waaraan in die Wet 'n betekenis geheg word, die betekenis aldus daaraan geheg, en tensy uit die samehang anders blyk, beteken—
 - “ansjovis” enige vis van die spesie *Engraulis capensis*;
 - “bottersnoek” enige vis van die spesie *Lepidopus caudatus*;
 - “die Wet” die Wet op Seevisserij, 1988 (Wet No. 12 van 1988);
 - “garnaal” enige skaaldier van die superfamilies Caridea en Penaeoidea met inbegrip van *Callianassa* en *Upogebia*;
 - “haai” enige vis van die klas *Chondrichthyes*
 - “koningklip” enige vis van die spesie *Genypterus capensis*;
 - “langoustine” enige skaaldier van die spesie *Metanephrops mozambicus* (voorheen *Metanephrops andamanicus*);
 - “marsbanker” enige vis van die spesie *Trachurus trachurus capensis*;
 - “monnikvis” enige vis van die spesie *Lophius vomerinus*;
 - “ooskusskaaldeiere” enige skaaldier, insluitende garnale, steurgarnale en langoustines wat in die waters van die provinsie KwaZulu-Natal aangetref en met bodemtreilnette gevang word;

“ooskustongvis” enige vis van die spesies *Austroglossus pectoralis*;

“perlemoen” enige skulpvis van die spesie *Haliotis midae*;

“pylinkvis” enige pylinkvis of tjokka pylinkvis *Loligo vulgaris reynaudii*;

“rooi gespikkeld tongvis” of “sandrat” enige vis van die spesie *Cynoglossus zanzibarensis*;

“rooi-oog” enige vis van die spesie *Etrumeus whiteheadi*;

“sardyn” enige vis van die spesie *Sardinops sagax*;

“seewier” enige mariene makro-alge, insluitende seebamboes [*Ecklonia maxima* en *Laminaria pallida* (*insluitende Laminaria Schinzii*)] en ander spesies soos *Gracilaria gracilis*, *Gracilaropsis spp* en *Gelidium spp*;

“snoek” enige vis van die spesie *Thyrsites atun*;

“stokvis” enige vis van die genus *Merluccius*;

“suidkuskreef” enige kreef van die spesie *Palinurus gilchristi*;

“tuna” enige vis van die spesies *Allothunnus fallai*, *Euthynnus affinis*, *Gymnosarda unicolor*, *Katsuwonus pelamis*, *Sarda orientalis* of *Sarda sarda* of enige spesie van die genus *Thunnus*

“weskuskreef” enige Kaapserots- of stekelrike kreef van die spesies *Jasus lalandii*; en

“weskustongvis” enige vis van die spesie *Austroglossus microlepis*

2. Behoudens paragraaf 3, betaal –

‘n Houer van ‘n reg om kommersiële visvangs van pelagiese vis te onderneem (pelagiese aas ingesluit), die volgende heffing per ton heelgewig vis:

R46.00 vir gerigte sardyn en R13.00 vir ansjovis, sardyn byvangs asook enige ander vis wat vir industriële doeleindes gebruik word.

3. By die toepassing van paragraaf 2 word die massa van sardyn, ansjovis, rooi-oog en marsbanker by ‘n visverwerkingsaanleg in die teenwoordigheid van ‘n visserybeheerbeampte bepaal (onderworpe aan paragraaf 15).

4. ‘n Houer van ‘n reg om kommersiële visvangs van weskuskreef te onderneem betaal ‘n heffing van R3744.00 per ton heelgewig weskuskreef ontvang/gevang (onderworpe aan

paragraaf 15).

5. ‘n Houer van ‘n reg om kommersiële visvangs van suidkuskreel te onderneem betaal ‘n heffing van R3126.00 per ton heelgewig of ‘n heffing van R6947.00 per ton stertmassa van suidkuskreel gevang.
6. Onderworpe aan paragraaf 15, betaal die persoon wat ‘n houer is van ‘n reg om kommersiële visvangs te onderneem by wyse van ‘n bodemtreil- of midwatertreilnet, die volgende heffing per ton heelgewig gevang:

Stokvis gevang in die aflandige- en midwater treil visserye: R181.00, stokvis gevang in die aanlandige treil vissery: R171.00, tongvis: R276.00, koningklip: R280.00, marsbanker: R15.00, pylinkvis: R342.00, ooskusskaaldiere: R135.00, monnikvis: R184.00, bottersnoek: R18.00 en snoek: R21.00.

7. ‘n Houer van ‘n reg om kommersiële visvangs van perlemoen te onderneem betaal ‘n heffing van R25 000.00 per ton heelgewig perlemoen ontvang/gevang.
8. ‘n Houer van ‘n reg om kommersiële visvangs van tradisionele lynvis te onderneem betaal die volgende heffings (vaste betaling per kategorie) op heelgewig vis gevang (onderworpe aan paragraaf 15):

9. ‘n Houer van ‘n reg om kommersiële visvangs van tuna (paal en lyn metode) te onderneem betaal ‘n heffing van R118.00 per ton heelgewig tuna gevang. Die heffings betaalbaar deur die houers van regte om tuna en swaardvis by wyse van ‘n langlyn te vang bly dieselfde soos gepubliseer in Goewermentskennisgwing no. 27067 van 8

Desember 2004.

10. 'n Houer van 'n reg om kommersiële visvangs van haai by wyse van 'n langlyn te onderneem betaal 'n heffing van R118.00 per ton heelgewig haai gevang (onderworpe aan paragraaf 15).
11. 'n Houer van 'n reg om kommersiële visvangs van stokvis by wyse van 'n langlyn te onderneem betaal 'n heffing van R181.00 per ton heelgewig stokvis asook R280.00 per ton heelgewig koningklip gevang (onderworpe aan paragraaf 15).
12. 'n Houer van 'n reg om kommersiële visvangs van stokvis by wyse van 'n handlyn te onderneem betaal 'n heffing van R135 per ton heelgewig stokvis gevang (onderworpe aan paragraaf 15).
13. 'n Houer van 'n reg om kommersiële visvangs van pylinkvis te onderneem betaal 'n heffing van R342.00 per ton heelgewig pylinkvis wat gevang word.
14. 'n Houer van 'n reg om kommersiële oestery van seewier te onderneem betaal 'n heffing van R95 per elke ton (drooggewig) seebamboes (*Laminaria pallida* [insluitende *laminaria schinzii*] en *Ecklonia maxima*) en R 207.00 per ton (drooggewig) van alle ander seewier spesies soos beskryf in paragraaf 1, versamel.
15. By die toepassing van paragraaf 3, 4, 6, 8, 10, 11 en 12 word die heelmassa van die vis bepaal deur die massa van die verwerkte visspesies gevang, soos aangedui in kolom 1 van die volgende tabel, te vermenigvuldig met die omsettingsfaktor soos aangedui.

Die heffings betaalbaar ten opsigte van die vis wat gedurende enige maand gevang is, moet voor die einde van die daaropvolgende maand betaal word, behalwe in die geval van tradisionele lynvis (paragraaf 8) waar die heffings voor 31 Desember van die betrokke jaar betaal moet word (gebaseer op die permithouers se eie vangsopgawes). Indien nodig, in geval van tradisionele lynvis, sal aanpassings ten opsigte van die heffings betaalbaar in die daaropvolgende jaar gemaak word en sal permithouers toegelaat word om die aangepaste heffings voor of op 30 Junie van die daaropvolgende jaar te betaal.
17. Alle betalings van heffings moet vergesel wees van 'n vorm, gesertifiseer deur die houer van die reg om kommersiële visvangs te onderneem, waarin die totale massa vis gevang of ontvang gedurende die betrokke maand (of maande in die geval van lynvis), getoon word. Hierdie vorm is verkrygbaar by: Mariene en Kusbestuur, 6de Verdieping, Foretrustgebou, Martin Hammerschlagweg, Strandgebied, Kaapstad / Privaatsak X2, Roggebaai, 8012.

18. Rente teen die rentekoers soos van tyd tot tyd deur die Tesourie bepaal, sal gehef word op enige uitstaande bedrae en sodanige rente word bereken vanaf die eerste dag van die maand wat volg op die maand waarin die vis geland is (behalwe in die geval van lynvis, waar dit bereken sal word vanaf die eerste dag van die jaar wat volg op die jaar waarin die vis gevang is).
 19. Heffings en rente betaalbaar ingevolge hierdie Bylae, moet betaal word aan: Mariene en Kusbestuur, 6de Verdieping, Foretrustgebou, Martin Hammerschlagweg, Strandgebied, Kaapstad / Privaatsak X2, Roggebaai, 8012.
 20. Enige persoon wat 'n bepaling van hierdie kennisgewing oortree of versuim om daaraan te voldoen is aan 'n misdryf skuldig en by skuldigbevinding strafbaar met 'n boete van hoogstens R50 000 of met gevangenisstraf vir 'n tydperk van hoogstens ses jaar of met sodanige boete sowel as sodanige gevangenisstraf.
