NOTICE OF INVITATION TO MAKE SUPPLEMENTARY COMMENTS ON THE PROPOSED
LICENCE CONDITIONS FOR THE SABC'S SOUND AND TELEVISION BROADCASTING
SERVICES**

In Government Gazette No. 27289, Notice No. 262 published on 14 February 2005, the Independent Communications Authority of South Africa ("the Authority") gave notice of the proposed amended terms and conditions of the sound and television broadcasting licences of the South African Broadcasting Corporation Limited ("SABC") for public comment.

The Authority has received written submissions from interested persons on the abovementioned proposed licence conditions, as well as the SABC's response to the proposed conditions and the interested persons' written submissions. The Authority hereby invites interested parties to make supplementary written submissions to the Authority on the SABC's abovementioned response, to the extent that it contains new material.

Interested persons wishing to make supplementary written representations are hereby invited to do so by no later than 6 May 2005.

The SABC shall be entitled to respond in writing to such supplementary written representations by no later than 13 May 2005. The SABC must, at the time of submitting its written response, furnish proof to the Authority's satisfaction that it has delivered a copy of the response by hand, or has sent a copy of the response by registered mail or by facsimile, to the relevant persons having made written representations.
