- 1. The Independent Communications Authority of South Africa (the Authority) hereby gives notice in terms of section 41 of the Independent Broadcasting Authority Act, 153 of the 1993 that it has received in terms of section 29 of the Broadcasting Act, 4 of 1999, as amended an application for a low power community sound broadcasting service. The details of the application are contained in the schedule below.

- 3. University of the Witwatersrand shall be entitled to respond in writing to written representations made by interested persons on the proposed renewal, and such written response must be lodged with the Authority within sixty (60) days of the date of publication of this notice in the Government Gazette.
