### NOTICE 1142 OF 2005

#### DEPARTMENT OF JUSTICE AND CONSTITUTIONAL DEVELOPMENT

#### PUBLICATION OF EXPLANATORY SUMMARY OF THE CONSTITUTIONAL MATTERS AMENDMENT BILL, 2005

The Minister for Justice and Constitutional Development intends introducing the Constitutional Matters Amendment Bill, 2005, in the National Assembly shortly. The explanatory summary of the Bill is hereby published in accordance with Rule 241(1)(c) of the Rules of the National Assembly.

The Bill amends the Public Funding of Represented Political Parties Act, 1997, so as to provide for the allocation of moneys from the Represented Political Parties' Fund to political parties participating in Parliament and provincial legislatures where a member of a legislature becomes a member of another party whilst retaining membership of that legislature or where an existing party merges with another party, subdivides into more than one party or subdivides and any one subdivision merges with another party; amends the Determination of Delegates (National Council of Provinces) Act, 1998, so as to make provision for the determination of certain delegates of a provincial legislature that has been reconstituted on account of changes of party membership and mergers or subdivision of parties; and provides for matters connected therewith.

WYSIGINGSWETSONTWERP OP GRONDWETLIKE AANGELEENTHEDE, 2005**

Die Minister vir Justisie en Staatkundige Ontwikkeling beoog om die Wysigingswetsontwerp op Grondwetlike Aangeleenthede, 2005, eersdaags in die Nasionale Vergadering in te dien. Die verduidelikende opsomming van die Wetsontwerp word hierby ooreenkomsdig Reël 241(1)(c) van die Reëls van die Nasionale Vergadering gepubliseer.

Die Wetsontwerp wysig die Wet op die Openbare Befondsing van Verteenwoordigde Politieke Partye, 1997, ten einde voorsiening te maak vir die toekenning van geld vanuit die Fonds vir Verteenwoordigde Politieke Partye aan politieke partye wat aan die Parlement en provinsiale wetgewers meedoен waar 'n lid van 'n wetgewer 'n lid van 'n ander party word terwyl lidmaatskap van daardie wetgewer behou word of waar 'n bestaande party met 'n ander party saamsmelt, in meer as een party onderverdeel of onderverdeel en enige onderverdeling met 'n ander party saamsmelt; wysig die Wet op die Bepaling van Afgevaardigdes (Nasionale Raad van Provincies), 1998, ten einde voorsiening te maak vir die bepaling van sekere afgevaardigdes van 'n provinsiale wetgewer wat hersaamgestel is as gevolg van veranderings van partylidmaatskap en samesmeltings of onderverdeling van partye; en maak voorsiening vir aangeleenthede wat daarvan in verband staan.
