APPLICATION FOR LOW POWER COMMUNITY SOUND BROADCASTING LICENCE: ZEBEDIELA COMMUNITY RADIO STATION

1. The Independent Communications Authority of South Africa ("the Authority") hereby gives notice, in terms of the provisions of section 41(6) of the Independent Broadcasting Authority Act, No 153 of 1993 ("the IBA Act"), as amended, that it has received in terms of section 41(3) of the IBA Act, as amended, an application from Zebediela Community Radio for a three year low power community sound broadcasting licence. The details of the application are contained in the schedule below.
2. The application is available and open for inspection by interested persons in the Authority's library during the Authority's normal office hours.
3. Interested persons are invited to lodge written representations in relation to the application by no later than 15 August 2005. 4. Persons who lodge representations in terms hereof must simultaneously indicate whether they also require an opportunity to make oral representations to the Authority.
5. Persons who lodge representations in terms hereof, shall at the time of lodgement furnish proof to the satisfaction of the Authority that a copy of the representation has been delivered by hand to Mr. Soul Mothoa, Station Manager, Zebediela Community Radio Station, Stand 101 Zebediela Shopping Complex, Zebediela Citrus Estate, Koringpunt, 0632 or sent by registered post to P.O Box 843, Koringpunt, 0632 or faxed to (015) 642 3129.

Zebediela Community Radio Station shall be entitled to respond in writing to written representations made by interested persons on the proposed three year low power community sound broadcasting licence, and such written response must be lodged with the Authority within sixty (60) days of the date of publication of this notice in the *Government Gazette*. Zebediela Community Radio Station must, at the time of lodging such written response, furnish proof to the Authority's satisfaction that it has delivered a copy of such response by hand, or has sent a copy of such response by registered mail or by facsimile to the relevant person having made such written representations.
