BOARD NOTICE 69 OF 2005 THE SOUTH AFRICAN PHARMACY COUNCIL

RULES RELATING TO GOOD PHARMACY PRACTICE

The South African Pharmacy Council intends to publish additional minimum standards to be added to Annexure A of *Rules relating to good pharmacy practice* published on the 17 December 2004 Government Gazette No: 27112 of Board Notice 129 of 2004 in terms of section 35A(b)(ii) of the Pharmacy Act 53 of 1974, as amended.

SCHEDULE

Rules relating to what constitutes good pharmacy practice

1. In these rules "the Act" shall mean the Pharmacy Act 53 of 1974, as amended, and any expression to which a meaning has been assigned in the Act shall bear such meaning.
2. The following minimum standards as published herewith for comments shall constitute additional standards to be added to Annexure A of the *Rules relating to good pharmacy practice* in accordance with section 35A(b)(ii) of the Act -
 - ☐ Minimum standards for emergency contraception
 - ☐ Minimum standards for cholesterol monitoring
 - ☐ Minimum standards for pregnancy tests
 - ☐ Minimum standards for products not sold in the pharmacy
 - ☐ Minimum standards for urine analysis
 - ☐ Minimum standards relating to the approval of tutors and premises for training of pharmacist interns and assistants
 - ☐ Minimum standards for the control of specified schedule 5 and schedule 6 substances
 - ☐ Minimum standards for glucose monitoring
