#### **PROMOTION OF ACCESS TO INFORMATION ACT, 2000 (ACT No. 2 OF 2000): EXEMPTION OF CERTAIN PRIVATE BODIES TO COMPILE MANUAL**

I, Brigitte Sylvia Mabandla, Minister for Justice and Constitutional Development, under section 51(4) of the Promotion of Access to Information Act, 2000 (Act No. 2 of 2000), hereby exempt -

- (a) all private bodies, except any company not being a private company as contemplated in section 20 of the Companies Act, 1973 (Act No. 61 of 1973), from compiling the manual contemplated in section 51(1) of the first mentioned Act for a period of four months from 1 September 2005 to 31 December 2005; and
- (b) all private bodies, except any company -
  - (i) not being a private company as contemplated in section 20 of the Companies Act, 1973; and
  - (ii) being a private company as contemplated in section 20 of the Companies Act, 1973, and which -
    - (aa) operate within any of the sectors mentioned in Column one of the Schedule to this Notice; and
    - (bb) has fifty or more employees in their employment; or
    - (cc) has a total annual turnover that is equal to or more than the applicable amount mentioned in Column 2 of the Schedule to this Notice,

from compiling the manual contemplated in section 51(1) of the first mentioned Act for a period of five years from 1 January 2006 to 31 December 2011.
