## REMUNERATION OF CONSTITUTIONAL COURT JUDGES AND JUDGES

- 1 In terms of section 2 of the Judges' Remuneration and Conditions of Employment Act, 2001 (Act No 47 2001) (hereinafter referred to as the Judges' Remuneration Act); I hereby determine the rate, as contained in the attached Schedule, at which salaries are payable to Constitutional Court Judges and Judges annually, with effect from 1 April 2005.
- 2 In terms of section 2(1) of the Judges Remuneration Act, I further determine that an annual allowance of R3 500.00 shall be payable to Constitutional Court Judges and Judges.
- 3 Proclamation No. 57 of 2004, published in Government Gazette No 26968 of 5 November 2004, is hereby repealed.


