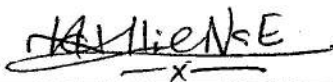

**NATIONAL ROAD N2, SECTION 7: EXTENSION OF THE EXISTING
TSITSIKAMMA TOLL ROAD BY DECLARING PART OF THE EXISTING
NATIONAL ROAD N2 SECTION 7 TOWARDS THE EAST OF THE EXISTING
TOLL ROAD, UP TO THE ELANDS RIVER, AS A TOLL ROAD**

In terms of Section 27 (1)(a)(i) of the South African National Roads Agency Limited and National Roads Act, 1998 (Act No 7 of 1998), the Agency hereby declares the following national road sections as a continuous Toll Road:

Portion of National Road N2 Section 7 starting at the end of the existing Tsitsikamma Toll Road, approximately 1 kilometre west of the Elandsbos River, as declared in Government Gazette 9163 of 05 April 1984, from where it continues in an easterly direction along the existing National Road N2 section 7, as declared in Government Gazette 11862 of 12 May 1989 and as amended in Government Gazette 26330 of 07 May 2004, up to the Elands River, roughly 150km west of Port Elizabeth.

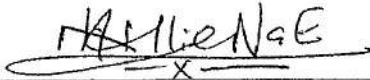

Ingevolge artikel 27(1)(a)(i) van die Wet op die Suid Afrikaanse Nasionale Padagentskap Beperk en Nasionale Paaie, (Wet 7 van 1998), verklaar die Agentskap hiermee die volgende Nasionale Pad roetes tot 'n ononderbroke Tolpad:

Gedeelte van Nasionale Pad N2 Seksie 7 beginnende by die einde van die bestaande Tsitsikamma Tolpad, ongeveer 1 kilometer wes van die Elandsbosrivier, soos verklaar in Staatskoerant 9163 van 05 April 1984. Van hier volg dit 'n oostelike rigting al langs die bestaande Nasionale Pad N2 Seksie 7, soos verklaar in Staatskoerant 11862 van 12 Mei 1989 en soos gewysig in Staatskoerant 26330 van 07 Mei 2004, tot by die Elandsrivier, ongeveer 150km wes van Port Elizabeth.
