1. P4 Radio Cape Town (Pty) Ltd seeks to change its name from P4 Radio Cape Town to HEART 104.9;
2. P4 Radio Durban (Pty) Ltd seeks to change its name from P4 Radio Durban to IGAGASI 99.5 .
3. Both licensees also want to change its Radio Data System (RDS) accordingly.
