APPLICATION FOR THE AMENDMENT OF LICENCE CONDITIONS: RADIO ORANJE (PTY) LTD

1. The Independent Communications Authority of South Africa ("the Authority") hereby gives notice, in terms of section 52(2)(a) of the Independent Broadcasting Authority Act, Act No 153 of 1993 ("the Act"), that it has received an application from Radio Oranje for the amendment of its broadcasting licence in terms of section 52(1)(c) of the Act.
2. This application is available for inspection by any interested parties during the Authority's normal office hours.
3. Interested parties are invited to lodge written representations in relation to the application within twenty one (21) days of the date of publication of this notice which will expire on 29 December 2005.
4. Radio Oranje shall be entitled to respond in writing to the written representations made by interested persons on the proposed amendments, and any such written response must be submitted to the Authority within sixty (60) days of the date of publication of this notice in the *Government Gazette*. Radio Oranje must, at the time of submitting its written response, furnish proof to the Authority's satisfaction that it has delivered a copy of the response by hand, or has sent a copy of the response by registered mail or by facsimile, to the relevant persons having made written representations.

SCHEDULE

1. According to the applicant, the proposed amendment will result in a change to clause 1 of Schedule C of its shareholding structure, which is currently as follows:

African Media Entertainment Limited ("AME")	69.81%
Kagiso Media Investments (Pty) Ltd	24.93%
OFM Staff Share Trust	5.26%

2. In terms of the application AME will acquire 0.27 of the ordinary shares held by the OFM Staff Share trust in the applicant.
3. Should the proposed amendment be approved AME's shareholding will increase from 69.81% to 70.10% whilst OFM Staff Share trust's shareholding would decrease from 5.26% to 4.97%. The shareholding of Kagiso Media Investments will remain at 24.93%.
4. The proposed amendment will also result in a change in the name of the applicant from Radio Oranje (Pty) Ltd to Seyalemoya Communications (Pty) Ltd, t/a OFM.
