DRAFT DETERMINATION OF ESKOM'S REVENUE REQUIREMENT FOR THE PERIOD 1 APRIL 2006 - 31 APRIL 2009

The National Electricity Regulator (NER) invites all stakeholders and the public to participate in the process of finalizing the Multi-Year Price Determination (MYPD) of Eskom for the period 1 April 2006 to 31 March 2009.
