- 4. Persons who lodge representations in terms hereof, must simultaneously indicate whether they also require an opportunity to make oral representations to the Authority.
- 5. Persons who lodge representations in terms hereof, shall at the time of lodgement furnish proof to the satisfaction of the Authority that a copy of the representation has been delivered by hand to Mr. Richard Perry, Station Manager, Tuks FM, University of Pretoria Lynnwood Road, Pretoria or sent by registered post to, PO Box 13762 Hatfield, 0028 or faxed to (012) 362 5313.

Tuks FM shall be entitled to respond in writing to written representations made by interested persons on the proposed renewal, and such written response must be lodged with the Authority within sixty (60) days of the date of publication of this notice in the *Government Gazette*. Tuks FM must, at the time of lodging such written response, furnish proof to the Authority's satisfaction that it has delivered a copy of such response by hand, or has sent
