The Independent Communications Authority of South Africa ("the Authority") hereby gives notice, in terms of section 52(2) (a) of the Independent Broadcasting Authority Act, Act No 153 of 1993 ("the IBA Act") as amended, that it has received an application from South African Broadcasting Corporation (Pty) Ltd (SABC) for the amendment of Lesedi FM broadcasting licence in terms of section 52(1) (c) of the IBA Act.
