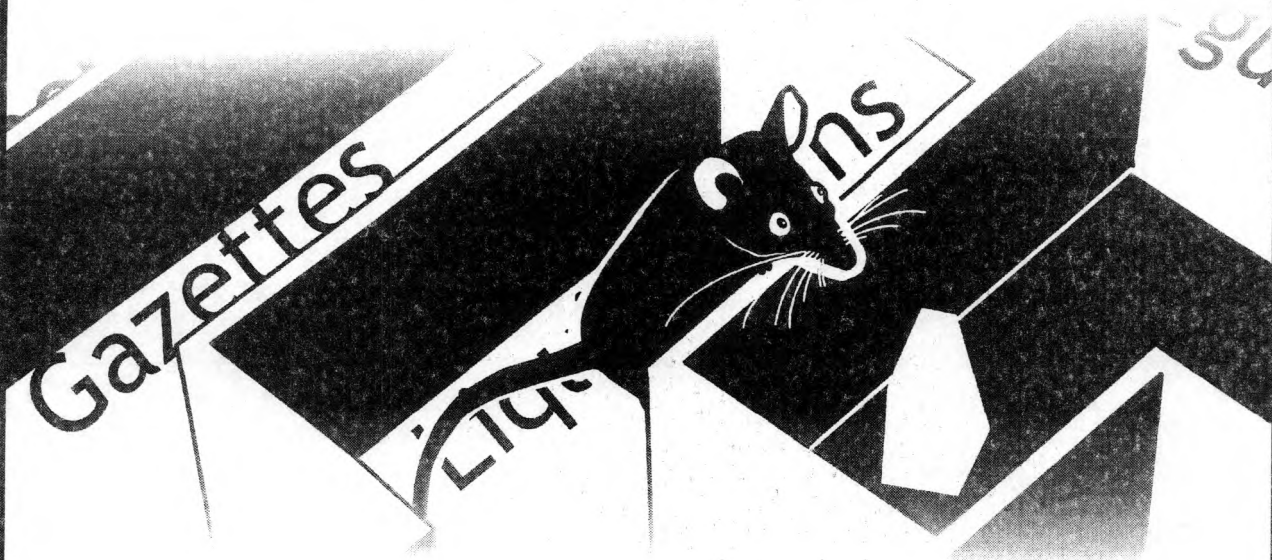
10. Proposed Amendments to technical licence conditions

- To replace the existing transmitter with an output power of 500 Watt, limited to an ERP of 1000Watt at the present Vemaakskop site, with a transmitter with an output power of 2000 Watt that will be limited to an ERP of 10 KW on the modulating frequency 103.8 MHz.
- To relocate the existing transmitter with an output power of 500Watt to act as a "gapfiller" at the Lovemore Heights site that will be limited to an ERP of 500 Watt but on a different frequency to be allocated by the Authority namely 107.5 MHz at Parsonshill.
