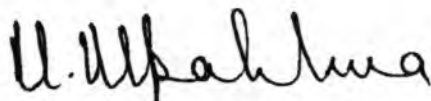

**INCORPORATION OF AN EXTERNAL COMPANY AS A COMPANY IN THE
REPUBLIC OF SOUTH AFRICA**

Now, therefore, under and by virtue of the powers vested in me by section 335 (2) of the Companies Act, 1973, I, Mandisi Mpahlwa hereby declare that JONAS INVESTMENTS shall be deemed, with effect from the date of termination of its registration and incorporation as a company in the Cayman Island, to be a company incorporated under Chapter IV of the Companies Act, 1973.
