SECTIONS 7, 7A AND 78 OF THE HERALDRY ACT, 1962 (ACT NO. 18 OF 1962)

The undermentioned bodies and persons have applied in terms of section 7 of the Heraldry Act, 1962 (Act No. 18 of 1962), for the registration of their heraldic representations. Anyone wishing to object to the registration of these heraldic representations on the grounds that such registrations will encroach upon rights to which he or she is legally entitled should do so within one month of the date of publication of this notice upon a form obtainable from the State Herald, Private Bag X236, Pretoria, 0001.

1. APPLICANT: Southern African Institute of Government Auditors (H4/3/1/3963)

FLAG: A rectangular flag, proportion 2:3, consisting of two horizontal bands, white above and green below, the white band being one third of the width of the flag, charged with a black portico with three sets of three pillars; the lower band per fess embowed of green and yellow, in chief five yellow plates placed in the form of an arch, and in base three green keys, two in saltire and one in pale, the bows interlinked and the wards forming the capital letter "E".

2. APPLICANT: Barolong Boora Tshidi Traditional Authority (H4/3/1/4066)

FLAG: A rectangular blue flag, proportion 2:3, there upon between two rows of four billets fesswise in pale with a kudu head and neck all of white.

3. APPLICANT: New West Secondary School (H4/3/1/4073)

ARMS: Per pale Murray and Argent, within an open laurel wreath an enflamed torch, and in base two interlinked annulets, all counterchanged.

MOTTO: LEAD BY EXAMPLE

4. APPLICANT: iMvula Quality Protection (H4/3/1/4075)

BADGE: Upon a bezant, within a decrescent, a droplet in umbra, Sable.

5. APPLICANT: Azwi Development Agency (H4/3/1/4084)

MEDAL: On an annulet Or, voided Azure, four emeralds, alternated with as many rubies, the annulet charged with a faceted eightpointed star Or, the points in saltire reduced; at the centre point an octagon Azure, charged with a buffalo head

caboshed Or. The annulet ensigned behind the upper point of the star with two elephant tusks in saltire Or, their points turned upwards.

RIBBON: A ribbon 50 mm wide consisting of a red band 9 mm, a white band 5 mm, a blue band 22 mm, a white band 5 mm and a red band 9 mm wide.

6. APPLICANT: Ditsobotla Local Municipality (H4/3/2/740)

ARMS: Azure, a maize-cob Or, leaved Vert, charged abalsse with two ears of wheat, their stems in saltire of the second, in each flank a cattle horn, and in base a cogwheel of the first; on a chief wavy a wall Argent, masoned Azure. The shield is ensigned of a rustic mural crown brunatre charged with a bar Or, there-upon a faceted diamond Azure.

MOTTO: ENTRUST AND CONQUER

7. APPLICANT: Ditsobotla Local Municipality (H4/3/2/740)

HERALDIC BANNER: A rectangular flag, proportion 2:3, in blue, a yellow maize-cob, with green leaves, charged abalsse with two yellow ears of wheat, their stems in saltire, in each flank a white cattle horn, and in base a cogwheel also white; on a chief wavy a white wall, masoned blue.

8. APPLICANT: Siyancuma Municipality (H4/3/2/775)

ARMS: Vert, a pall inverted wavy Azure, fimbriated Argent, between in chief dexter a round hut proper, sinister within a set of kudu horns Argent, a maize stamp-pot Or; on a base per chevron Gules and Sable, a chevronel Or, and in base a maize-cob Argent, leaved Vert. The shield is ensigned, in front of a spear and knobkierie in saltire proper, of a rustic mural crown Or, charged with a

diamond between two stars Azure, issuant there from a indigenous, stone hut proper.

MOTTO: GA BO SEGANGWE

9. APPLICANT: Lepelle-Nkumpi Local Municipality (H4/3/2/813)

ARMS: Per chevron embowed Vert and Argent, at honour point a maize-cob Argent, leaved Or, between dexter an Afrikaner bull head caboshed and sinister a lions face proper, in base a cogwheel Sable, charged with a bee Or, issuant from each flank of the cogwheel an orange tree branch with two oranges to base, a base wavy Azure; on a chief dancetty the peaks embattled Or, a pangolin proper. The shield is ensigned of a crest coronet Or, charged with a bar Azure, heightened of four strawberry leaves, embellished with pearls and alternated with as many pearls Argent. The shield is flanked dexter by an elephant tusk and sinister by two porcupine quills proper.

MOTTO: MOTHO KE MOTHO KA BATHO

10. APPLICANT: Heidi Garcia Bosch Morales (Adriaansen) (H4/3/4/788)

ARMS: Azure, within a ring of twelve five pointed stars Or, a doe at rest Or and in chief a fleur-de-lis Argent. The Shield is ensigned of a narrow turned heading Argent, heightened of four visible flowers namely an orange blossom Argent, seeded Or, a protea Or, seeded Argent, a thistle Or, and a poppy Or, each alternated with as many fleurs-de-lis Argent, issuant from the coronet an upward gazing cherub proper with wings Or, in his right hand a five-pointed star Or.

MOTTO: SAN JOSE

11. APPLICANT: Johanna Catharina Gurney (Ferreira) (H4/3/4/826)

ARMS: Per fess and in chief per pale dexter Azure, sinister paly bendy Azure and Argent, and in base Vert, in chief dexter three five-pointed stars Argent, placed one and two, and in base a rake and shovel in saltire proper; over all a cross Argent, charged with a bar wavy Azure, on its upper limb a pink carnation slipped and leaved proper, and on its lower limb an inescutcheon Gules, there upon five plates placed two, one and two, Argent.

MOTTO: DANKBAARHEID

12. APPLICANT: Luis Guillermo Fernandez Carreno (H4/3/4/864)

ARMS: Per chevron rayonne Argent and Gules, in chief dexter an eagle with wings displayed Azure, sinister a Jerusalem cross Gules and in base a lion rampant Argent.

CREST: In front of a rod of aesculapius Azure, with entwined snake Or, two swords in saltire Argent, with grip Gules, hilted and pommelled Or.

WREATH AND MANTLING: Gules and Argent.

MOTTO: DEUS LO VULT

13. APPLICANT: Richard Stephen Binstead (H4/3/4/868)

ARMS: Argent, twenty teardrops proper, placed 6, 5, 4, 3, and 2; on a chief indented Vert, a white Saxon horse courant proper.

CREST: Two battle axes in saltire proper.

WREATH AND MANTLING: Vert and Argent.

## MOTTO:MANNANGENGA

## 14. APPLICANT: Barry Gonin (H4/3/4/873)

ARMS: Per chevron Argent and Azure, in chief dexter a paintbrush and quill pen in saltire and sinister a dovetailed annulet all of the first, and in base within two interlinked triangles Argent, a heart Or; on a chief inverted of three Azure, three bezants.

CREST: A demi-esquire, his tunic Gules, his collar, waist and shoulder belt Argent, his dexter hand lowered, opened and holding a heart Gules, his sinister hand raised and holding a hand balance also Gules.

WREATH AND MANTLING: Azure and Or.

MOTTO: HONOR ET INTEGRITAS

## 15. APPLICANT: Joachim Prinsloo Bekker (H4/3/4/875)

1. AANSOEKER: Southern African Institute of Government Auditors (H4/3/1/3963)

VLAG: 'n Reghoekige vlag, verhouding 2:3, bestaande uit twee horisontale bane, wit bo en groen daaronder, die wit baan een derde van die vlaghoogte belaa met 'n swart portiek met drie stelle van drie suile; die onderste baan geboe, kepersgewys verdeel van groen en geel, daarbo vyf plate **geboë** geplaas van geel, en in die basis drie groen sleutels, twee skuins gekruis en een regop geplaas, hul ringe ineengeskakel en hul baarde in die vorm van die hoofletter "E".

2. AANSOEKER: Barolong Boora Tshidi Tradisionele Owerheid (H4/3/1/4066)

VLAG: 'n Reghoekige blou vlag, verhouding 2:3, daarop tussen twee rye van vier dwarsbalksgewys bokant mekaar geplaaste blokkies 'n koedoekop en -nek alles van wit.

3. AANSOEKER: New West Secondary School (H4/3/1/4073)

WAPEN: Deursnede van maroen en silwer, binne in 'n oop lourierkrans, 'n gevlamde fakkel, en in die skildvoet twee ineengeskakelde ringe, alles van die een in die andere

4. AANSOEKER: iMvula Quality Protection (H4/3/1/4075)





- 4 to implement all recommendations contained in the rehabilitation plan within thirty days of approval thereof by the Department."

Take notice that it is my opinion that past and proposed development- and/or construction-related activities on the property by Blue Moonlight and/or its agents have or may seriously damage, endanger or detrimentally affect the environment. The said environment includes a sensitive ridge system and a Red Data Plant species, *cerepigia decidua* supsp. *Pretoriensis* found on and/or near the property. The reasons for my aforementioned opinion are set out in my affidavits filed in Case No 9114/2007 before the Transvaal Provincial Division of the High Court, including the annexures thereto.
