SMALL CLAIMS COURTS ACT, 1984 (ACT NO. 61 OF 1984)

ALTERATION OF THE AREA FOR WHICH THE SMALL CLAIMS COURT OF PRETORIA WAS ESTABLISHED AS PUBLISHED IN GOVERNMENT NOTICE NO. 2096 OF 20 SEPTEMBER 1985 AS AMENDED BY GOVERNMENT NOTICE NO. 1743 OF 26 JUNE 1992: ESTABLISHMENT OF A SMALL CLAIMS COURT FOR THE AREA OF SOSHANGUVE

I, Johannes Hendrik De Lange, acting under the powers delegated to me by Brigitte Sylvia Mabandla, Minister for Justice and Constitutional Development, under section 2 of the Small Claims Courts Act, 1984 (Act No. 61 of 1984), hereby-

- (a) alter the area for which the Small Claims Court of Pretoria was established by excising therefrom the district of Soshanguve; and
- (b) amend Government Notice No. 2096 of 20 September 1985 as amended by Government Notice No. 1743 of 26 June 1992 to reflect that the area of the Small Claims Court of Pretoria, consisting of the districts of Pretoria and Wonderboom; and
- (c) (i) establish a small claims court for the adjudication of claims for the area of Soshanguve, which consist of the district Soshanguve;
 - (ii) determine Soshanguve to be the seat of the said court; and

(iii) determine Soshanguve to be the place in that area for the holding of sessions of the said court.

Notwithstanding the altering and amendment of the Government Notices, contemplate in paragraph (b) above, the adjudication of claims from the district Soshanguve which have already been led in respect of such a claim, shall, if such adjudication have at the date, when the Small Claims Court for Soshanguve has been established by this notice in the Gazette, not been concluded, be continued and concluded in the Small Claims Court of Pretoria as if the area of the Small Claims Court of Pretoria had not been altered.
