#### **Definitions**

1. #### SCHEDULE

#### **Definitions**

1. In this schedule the Regulations mean the regulations published by Government Notice R 1948 of 19 October 1973, as amended by Government Notice R2384 of 14 December 1973; Government Notice R55 of 11 January 1974; Government Notice R.119 of 17 January 1975; Government Notice R.1665 of 10 September 1976; Government Notice R.1911 of 22 October 1976; Government Notice R.787 of 6 May 1977; Government Notice R.2044 of 7 October 1977; Government Notice R.1391 of 30 June 1978; Government Notice R.1758 of 17 August 1979; Government Notice R.1121 of 6 June 1980; Government Notice R.1759 of 29 August 1980; Government Notice R.2443 of 13 November 1981; Government Notice R.559 of 26 March 1982; Government Notice R.873 of 19 April 1985; Government Notice R.2348 of 18 October 1985; Government Notice R.539 of 27 March 1986; Government Notice R.1962 of 30 September 1988; Government Notice R.415 of 10 March 1989: Government Notice R.601 of 31 March 1989; Government Notice R.736 of 21 April 1989; Government Notice R.2090 of 29 September 1989; Government Notice R.1110 of 4 September 1998; Government Notice R.762 of 18 June 1999; Government Notice R.1712 of 18 November 2003; (as corrected by Government Notice R.1790 of 8 December 2003); and Government Notice R.607 of 1 July 2005

#### Insertion of regulation 2A in the Regulations

2. The following regulation is hereby inserted after regulation 2:

#### "Notices under the Act

Whenever a notice must be given under section 28, 29C, 43, 44, 73 or 419 of the Act, it shall be given by the publication of a notice on the CIPRO portal.".

#### Amendment of regulation 19 of the Regulations

3. Regulation 19 is hereby amended by the substitution for paragraph (a) of sub-regulation (1) of the following paragraph:

"(a) the original [and two copies of the] memorandum and articles referred to in regulations 17 and 18 [, bound as prescribed in regulation 4 (1)];".

#### Amendment of regulation 20 of the Regulations

- **4.** Regulation 20 is hereby amended by the substitution for paragraph (a) of subregulation (1) of the following paragraph:
  - "(a) the original [and two copies of the] memorandum and articles referred to in regulations 17 and 18 [, bound as prescribed in regulation 4 (1)];".

#### Amendment of regulation 21 of the Regulations

Regulation 21 is hereby amended by the deletion of sub-regulation (3).

#### Insertion of heading and regulations 27B and 27C in the Regulations

6. The following headings and regulations are hereby inserted in the Regulations after regulation 27A:

#### "REGISTRATION OF SUPPLEMENT TO PROSPECTUS

- 27B. A supplement to a prospectus that is required to be registered in terms of section 148 of the Act, must contain:
  - (a) full particulars of the relevant error, new matter or change; and
  - (b) a full reference to the relevant paragraph in the prospectus as registered.

#### **APPLICATION TO OMIT INFORMATION IN PROSPECTUS**

- 27C. (1) An application under section 148A of the Act to omit information required by section 148 must:
  - (a) identify the information concerned; and
  - (b) be supported by a full motivation.
- (2) The prescribed fee set out in item 5B of Schedule 1 shall be payable in respect of such application.".

## Amendment of regulation 28 of the Regulations

- Regulation 28 is hereby amended by the addition of the following subregulation:
  - "(4) If a company has been deregistered due to its failure to lodge an annual return in terms of section 173 of the Act, the following documents must be lodged with the Registrar, together with the prescribed application fee set out in item 20A of Schedule 1:
    - (a) Form CM 17 to lodge the annual return late;
    - (b) a written application for the restoration of the company;
    - (c) proof of lodgment of the outstanding annual return; and
    - (d) proof of payment of the relevant outstanding annual return prescribed fee.".
