The National Qualifications Framework; the responsibilities of Ministers; the South African Qualifications Authority; Quality Councils; transitional arrangements, repeal of the South African Qualifications Authority Act, 1995; and matters connected therewith.

The Higher Education Amendment Bill, 2008, provides for -

The amendment of the Higher Education Act, 1997, so as to make it consistent with the National Qualifications Framework Act, 2008; and matters connected therewith.

The General and Further Education and Training Quality Assurance Amendment Bill, 2008, provides for -

The amendment of the General and Further Education and Training Quality Assurance Act, 2001, so as to make it consistent with the National Qualifications Framework Bill, 2008; and matters connected therewith.
