ACT

To amend the Repeal of the Black Administration Act and Amendment of Certain Laws Act, 2005, so as to substitute a date; and to provide for matters connected therewith.

BE IT ENACTED by the Parliament of the Republic of South Africa, as follows:—

Amendment of section 1 of Act 28 of 2005, as amended by section 1 of Act 8 of 2006 and section 1 of Act 13 of 2007

1. Section 1 of the Repeal of the Black Administration Act and Amendment of Certain Laws Act, 2005, is hereby amended by the substitution in subsection (3) for paragraph (a) of the following paragraph:

“(a) [30 June 2008] 30 December 2009; or”.

Short title and commencement

2. This Act is called the Repeal of the Black Administration Act and Amendment of 10 Certain Laws Amendment Act, 2008, and comes into operation on 29 June 2008.

Tot wysiging van die Wet op die Herroeping van die Swart Administrasie Wet en Wysiging van Sekere Wette, 2005, ten einde 'n datum te vervang; en om voorsiening te maak vir aangeleenthede wat daarmee in verband staan.

DAAR WORD BEPAAL deur die Parlement van die Republiek van Suid-Afrika, soos volg:—

Wysiging van artikel 1 van Wet 28 van 2005, soos gewysig deur artikel 1 van Wet 8 van 2006 en artikel 1 van Wet 13 van 2007

1. Artikel 1 van die Wet op die Herroeping van die Swart Administrasie Wet en Wysiging van Sekere Wette, 2005, word hierby gewysig deur in subartikel (3) paragraaf (a) deur die volgende paragraaf te vervang:
“(a) [30 Junie 2008] 30 Desember 2009; of”.
