### APPOINTMENT OF MINISTERIAL COMMITTEE ON NATIONAL EDUCATION EVALUATION AND DEVELOPMENT UNIT (NEEDU)

I, Grace Naledi Mandisa Pandor, MP, Minister of Education, hereby appoint a Ministerial Committee on the National Education Evaluation and Development Unit (NEEDU).

#### TERMS OF REFERENCE

##### AIM

1. The central task of the Ministerial Committee is to recommend to the Minister, mechanisms through which *independent* evaluation and development of schools can be undertaken.

#### MANDATE AND BACKGROUND

2. The Government has been mandated to establish a national education evaluation and development unit for purposes of monitoring, evaluation and support.
3. In pursuance of this mandate, the Minister wishes to explore the establishment of an external unit, outside of the Department of Education, but accountable to the Minister, that would be responsible for the independent evaluation and development of schools (including teachers). The unit is expected to serve at an "arms length" authority.
4. The unit is expected to monitor, evaluate and report on all public schools over a cycle of years against national norms and standards.
5. The unit will utilize its own programme and method of evaluation but will ensure integration of its own measurement instruments and if necessary of its processes with existing measurement instruments and processes such as the Integrated Quality Management System, Systemic Evaluation and Whole School evaluation.

#### SCOPE OF WORK

6. The Committee will undertake the following in cooperation with Mr D Hindle, the Director-General of Education:
  - a. Review all existing policies, mechanisms, structures, processes and tools that evaluate and develop schools and teachers.

- b. Review the international literature on similar school evaluation and development bodies in other countries.
- c. Make recommendations on the structure and composition, location, functions, governance, name, cost and financing of an external organisation, accountable to the Minister, which will have the overall task of school evaluation and development.
- d. Advise on the relationship between the proposed unit and existing policies and mechanisms aimed at school (including teacher and learner) evaluation and development.
- e. Report to the Minister of Education on the Committee's findings and recommendations.
- f. Propose to the Minister a refinement of these terms of reference, if necessary.

#### **COMPOSITION OF THE MINISTERIAL COMMITTEE**

7. The following persons will be appointed to serve on the ministerial committee:

- Dr Jonathan D Jansen (Chairperson)
- Dr R Cassius Lubisi
- Dr Peliwe P Lolwana
- Ms Francine de Clercq
- Ms Amanda Sanger
- Ms C Sussana Muller
- Dr Peter Matthews
- Prof. Linda Darling-Hammond
- Two representatives from the School Governing Bodies to be further approved by the Minister
- Two representatives from trade unions in education to be further approved by the Minister

#### **TIME FRAMES**

8. The Committee will be appointed to commence with its activities by 1<sup>st</sup> September 2008 and should conclude its work by 31<sup>st</sup> December 2008.

#### **REPORT ON INVESTIGATION AND RECOMMENDATION**

9. The Committee must report on the investigation and make recommendations to the Minister of Education by 5<sup>th</sup> January 2009.

**FINANCIAL AND ADMINISTRATIVE MATTERS**

10. Committee members will be paid a daily honorarium at Government's standard rates for Ministerial Committees.
11. The Committee will be expected to submit a business plan to the Minister, which will include the plan of work of the Committee and the estimated cost of this work.
12. The Department will make all travel and accommodation arrangements of Committee members, subject to Government rates.
13. The Department will reimburse all other administrative expenditure that Committee members incur in carrying out the work stipulated in the business plan. To this end, the chairperson of the Committee must approve and sign invoices and forward them to the Department. Claims of the Committee must be made in accordance with the rules of the Public Finance Management Act, 1999 (the PFMA).

**REGULATIONS IN TERMS OF SECTION 47, READ WITH SECTION 26(4) OF THE  
NATIONAL NUCLEAR REGULATOR ACT, 1999 (ACT NO. 47 OF 1999), ON THE  
ESTABLISHMENT OF A PUBLIC SAFETY INFORMATION FORUM BY THE  
HOLDER OF A NUCLEAR INSTALLATION LICENCE TO INFORM THE PERSONS  
LIVING IN THE MUNICIPAL AREA IN RESPECT OF WHICH AN EMERGENCY  
PLAN HAS BEEN ESTABLISHED**

Under section 47 of the National Nuclear Regulator Act, 1999 (Act No. 47 of 1999), I B P Sonjica, Minister of Minerals and Energy, after consultation with the Board of Directors of the National Nuclear Regulator, hereby make the regulations in the Schedule.

**SCHEDULE****Definitions**

1. In these regulations any word or expression to which a meaning has been assigned in the Act, shall have the meaning so assigned.

**Terms not defined in the Act**

2. In these regulations—

- (i) “nuclear safety” means the achievement of safe operating conditions, prevention of nuclear accidents or mitigation of nuclear accident consequences, resulting in the protection of workers, the public and the environment against the potential harmful effects of ionizing radiation or radioactive material;
- (ii) “radiation safety” means the protection of persons and the environment against the potential harmful effects of ionizing radiation or radioactive material, and
- (iii) “relevant municipal area” means that part of a municipal area which falls within the formal emergency planning zone of a nuclear installation.

**Responsibilities of holders of a nuclear installation licence**

3. A holder of a nuclear installation licence must—

- (a) establish a public safety information forum in order to inform the persons living in the relevant municipal area in respect of which an emergency plan has been established in terms of section 38(1) of the Act on nuclear safety and radiation safety matters related to the relevant nuclear installation;
- (b) provide a venue and facilities for meetings of the forum;
- (c) by public notice call upon interested and affected parties living in the relevant municipal area to register with the Public Safety Information Forum;
- (d) provide a secretariat to facilitate the functioning of the forum and to maintain a contact data base of persons living in the relevant municipal area that have registered with the forum as interested and affected parties;
- (e) provide information to the forum, with due regard to section 51 of the Act, on nuclear/radiation safety matters, including but not limited to nuclear incidents/accidents, and
- (f) cover the costs related to the establishment and management of the forum.

**Functioning of the Public Safety Information Forum**

4. (1) The Forum shall have a Chairperson and a Deputy Chairperson who shall hold office for a period of two years.

(2) The Chairperson and Deputy Chairperson shall be appointed by the Board of Directors of the National Nuclear Regulator from persons living in the relevant municipal area three months prior to the end of the expiring term.

(3) In order to select a Chairperson and Deputy Chairperson the Board of the National Nuclear Regulator shall invite nominations in at least two local newspapers and from persons registered with the forum as contemplated in 3(c).

(4) Persons appointed as contemplated in subsection (2) must accept the appointment in writing and perform their duties without payment.

(5) The public safety information forum must—

- (a) conduct all meetings open to any member of the public at a minimum frequency of one meeting per quarter;
- (b) communicate the date, time and venue of meetings of the forum within the relevant municipal area, not less than 14 days prior to each meeting, by advertising in at least two newspapers circulating in the relevant municipal area;
- (c) keep minutes of all meetings as a record, which must be distributed to all attendees and any other interested parties, and
- (d) invite the National Nuclear Regulator, the relevant municipality (Disaster Management Centre), the relevant Province (Disaster Management Centre) and relevant national government departments as appropriate, to all meetings to facilitate the sharing of information.

### **Constitution**

5. The Public Safety Information Forum may establish a constitution not inconsistent with these regulations.

4.2 The allocation of quotas for permits will be done as follows:

- (b) BEE importers either on an equal basis or as a historical importer, whichever will enhance government policy for BEE development.
- (c) Historical importers in proportion to the average quantity of the product concerned, imported by the applicant during the past three years (submitted for each year as from 1 November to 31 October) or the period stipulated for the product in column 5 of the Table.

4.3 The quantity imported by a historical importer will be calculated on the basis of a detailed list of bills of entry for the product concerned submitted together with the application form, for the period stipulated for the product in column 5 of the Table.

4.4 (a) If the allocation for a particular category is not fully utilised, the balance may be re-allocated to the other categories, or may be held over for the particular category for the following application period stipulated for the year under consideration.

(b) In order to enhance government policy on BEE's, quotas for importers in the SMME and new importer's category, as well as the BEE category can be combined to ensure the most beneficial allocation.

4.5 If the market share for a particular applicant exceeds the limit for dominant firms, contemplated in Article 7(a)-(c) of the Competition Act, Act 89 of 1998 as amended in 2000 the Department can adjust the allocation formula to create fair competition within that industry sector.

4.6 Despite any provision in other law, applicants registered as joint ventures, mergers, consortiums, holding companies or other similar business arrangements are not allowed to apply separately from their subsidiaries, minority shareholders or divisions for the same product, as this will establish an unfair advantage towards other applicants.

4.7 A lost permit will only be replaced if an affidavit in this regard has been submitted and the Department is satisfied that the applicant acted in good faith and took the necessary steps to recover the original permit, as well as undertake to return the original permit if it is found. **NOTICE 1126 OF 2008****INTERNATIONAL TRADE ADMINISTRATION COMMISSION OF SOUTH AFRICA****TERMINATION OF THE INVESTIGATION INTO THE ALLEGED DUMPING OF CITRIC ACID ORIGINATING IN OR IMPORTED FROM THE PEOPLE'S REPUBLIC OF CHINA: FINAL DETERMINATION**

On 23 February 2007, the International Trade Administration Commission of South Africa (the Commission) formally initiated an investigation into the alleged dumping of citric acid originating in or imported from the People's Republic of China (PRC). Notice of initiation of the investigation was published in Notice No. 194 of 2007 of *Government Gazette* No. 29636 dated 23 February 2007.

The Application was lodged on behalf of the Southern African Customs Union (SACU) industry by Isegen South Africa (Pty) Ltd (Isegen), being the sole manufacturer of malic acid in SACU, which claimed that dumped imports were causing it material injury.

The investigation was initiated after the Commission considered that there was *prima facie* evidence to show that the subject product was being imported at dumped prices, causing material injury to the SACU industry.

On 31 August 2007, after considering information submitted by the interested parties, and the research conducted, the Commission made a preliminary determination that citric acid originating in or imported from the PRC, and malic acid manufactured locally by the applicant, are not like products for purposes of comparison, in terms of section 2.6 of the Anti-Dumping Agreement. Based on the above, the Commission made a preliminary determination to terminate the investigation. The Commission's reasons for its decision were detailed in its Report No.246. Interested parties were invited to comment on its preliminary report.



On 11 March 2008, after undertaking further research on the issue of “like” product, and considering comments submitted by interested parties to its preliminary report, the Commission made a final determination that citric acid and malic acid are not “like” products, for purposes of comparison in terms of the ADR and Article 2.6 of the WTO Anti-Dumping Agreement.

The Commission’s detailed reasons for its decision are set out in Commission Report No.267.






