#### N2 NORTH COAST TOLL ROAD: NOTICE OF INTENT TO DECLARE A PORTION OF SECTION 26 OF NATIONAL ROUTE 2 AS A TOLL ROAD


In terms of Section 27(4)(a) of The South African National Road Agency Limited and National Roads Act, 1998 (Act No. 7 of 1998), the South African National Roads Agency Limited hereby gives notice of its intention to apply to the Minister of Transport to approve the declaration of a portion of Section 26 of National Route 2 declared as a National Road by Government Notice 1099 of 14 October 2008, as a toll road.

In terms of section 27(4)(a)(i) of the said Act the approximate position of the toll plaza is indicated in Figure 1 marked as New Southern Ramp Plaza, being a plaza on the southbound carriageway on-ramp of the new interchange on N2-26 at approximately km 15,9

In terms of Section 27(4) (a) (ii) of the said Act all interested persons are hereby invited to comment and make written representations on the proposed declaration and position of the toll plaza, by 09 December 2008 ("closing date"), being a date not less than 30 days from the date of this notice. All written representations must be addressed to the Regional Manager: Eastern Region, The South African National Roads Agency Limited and be:






